The grant of MACP is further subject to the following conditions:

1. The officials concerned may be allowed to exercise his/her options, if any, under FR - 22 within one month of the issuance of this order.



2. The grant of higher pay scale is subject to the undertaking that in the event of overpayment, which may be detected at a lower stage the same will be recovered from their pay.
3. Officials who are on deputation will get financial Upgradation from the date shown against his name only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation.
4. No stepping up of Pay in the Level would be admissible with regard to junior getting more pay than the senior consequent upon pay fixation after MACP.
5. The financial upgradation under the scheme shall be purely personal to the employee and shall have no relevance to his/her position. There shall be no additional upgradation for senior employee on the ground that a junior employee in the grade has got higher pay after the MACP.
6. The concerned DDO is requested to verify the service particulars with regard to concerned official and discrepancies, if any, be brought to the notice of this office.
