3. Option regarding fixation of pay under the FR 22 (1) (a) (1), if any, may be exercised within one month from the date of the issue of this order. The option once exercised shall be final.

The MACP is further subject to the relevant terms and conditions mentioned in the Office Memorandum No. DOPT-1669022409144 dated 21.11.2022 issued by the Govt. of India, Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training, ESTT.
