In pursuance to the order issued by the office of Controller General of Accounts under the reference no. A-22012/7/2020-Group A-CGA-Part (1)/58 dated 17.04.2026 and consequent upon the joining of Ms. Deepti Bagga, ICAS (2019), DCA in O/o DCA (EZ), CBIC, Kolkata, the competent authority has decided the following work allocation in r/o Ms. Deepti Bagga, DCA (EZ) with immediate effect till further orders:

1. She will look after the charge of O/o Dy.CA (East Zone), CBIC at Kolkata as Zonal Head (East Zone). As the Zonal head, she shall supervise the functioning of all field PAOs of East Zone.

2. She will look after the work of streamlining the REVACT route of accounting and shall coordinate with the GIFMIS (PFMS) in this regard.

3. She will look after the work related to the IT proposals requiring integration with PFMS/ARPIT.

4. She will be the first Appellate Authority for RTI matters in r/o all the CPIOs under jurisdiction of EZ (CBIC), Kolkata.


5. She will look after the CPGRAMS related matter in r/o all the PAOs under jurisdiction of EZ (CBIC), Kolkata.

6. She will also provide all necessary support to the Sr. CA, CBIC (WZ), Mumbai in the work related to all types of refunds being operationalized through GST-PFMS and ICEGATE-PFMS integration and will report to him for this purpose.

For the work related to Sl. No. 2 and 3 she shall report to Sr. CA (HQ).

The date of taking over of charge of the post may be intimated to this office in due course.

This issues with the approval of the Competent Authority.


