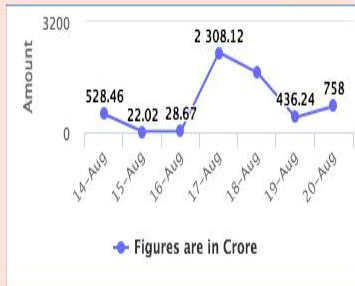

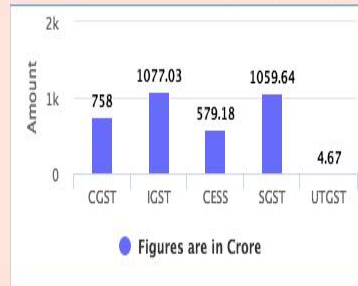

# INDIRECT TAX COLLECTION

## DECEMBER, 2020

### Executive Summary

#### *Gross Collections*

- Gross collection of Indirect Taxes (including GST) up to **December, 2020** is **Rs. 9,31,499.75 crore** in comparisons to **Rs. 9,45,743.11 crore** during COPPY, showing a decline of **1.51%**. Out of the Total Gross collection, the share of **CGST** is **Rs. 1,43,895.61 crore**, **UTGST (OT)** is **Rs. 114.79 crore**, **IGST** is **Rs. 3,93,516.38 crore**, **Compensation Cess** is **Rs 61,080.75 crore**, **Custom Duty** is **Rs 94,038.44 crore**, **UED** is **Rs 2,37,021.44 crore** and **Service Tax** is **Rs 1,832.34 crore**.

#### *Net Collections (Total)*

- Net collection up to **December, 2020** is **Rs. 7,12,681.77 crore** as compared to **Rs. 6,83,463.40 crore** during COPPY showing a growth of **4.28%**. The net collection is **64.99%** of the BE of **Rs. 10,96,520 crore**.

#### *Custom Duty (Net)*

- Net collection up to **December, 2020** is **Rs. 79,591.59 crore** which is **57.68%** of **B.E.**

#### *Customs Duty drawback and Refund*

- The Custom duty drawback & Refund payments up to **December, 2020** are **Rs. 14,446.85 crore**. (15.36% of Gross Collections)

#### *Union Excise Duty (Net)*

- Net collection of Excise Duty up to **December, 2020** is **Rs. 2,35,992.77 crore** which is **88.39%** of **B.E.**

#### *Union Excise Duty Refund*

- The UED Refund payments up to **December, 2020** are **Rs. 1,028.67 crore**. (0.43% of Gross Collections)

### ***Service-Tax (Net)***

- Net collection of Service Tax up to December, 2020 is Rs. 1,186.10 crore which is 116.28% of BE.

### ***Service Tax Refund***

- The Service Tax Refund payments up to December, 2020 are Rs. 646.24 crore. (35.27% of Gross Collections)

### ***CGST (Net)***

- Net Collection of CGST up to December, 2020 is Rs. 2,88,222.67 crore. It includes the share of regular Settlements and Advance Apportionment from IGST, added through book adjustments.

### ***UTGST (OT) (Net)***

- Net Collection of UTGST (OT) up to December, 2020 is Rs. 449.99 crore.

### ***IGST (Net)***

- Net collection of IGST up to December, 2020 is Rs. 48,157.46 crore. This is after Refunds and monthly regular settlements as well as Advance Apportionments.

### ***Compensation Cess (Net)***

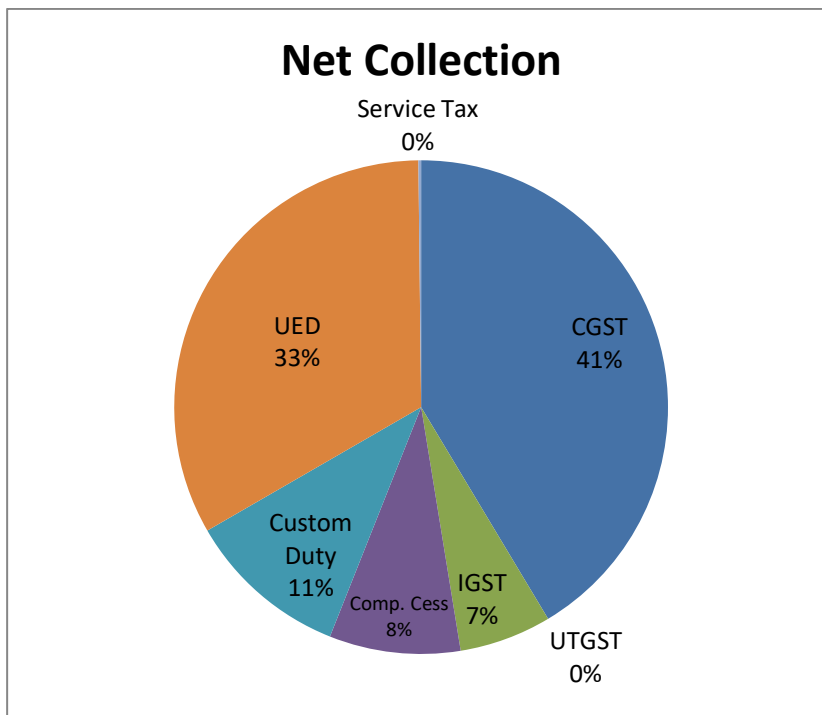
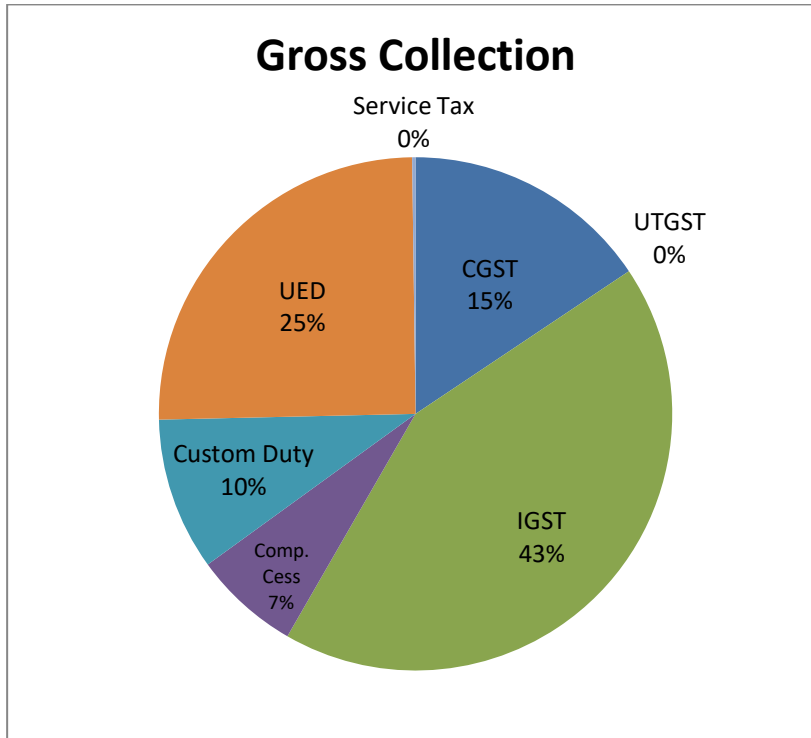
- Net (after Refund) collection of Compensation Cess up to December, 2020 is Rs. 59,081.19 crore.

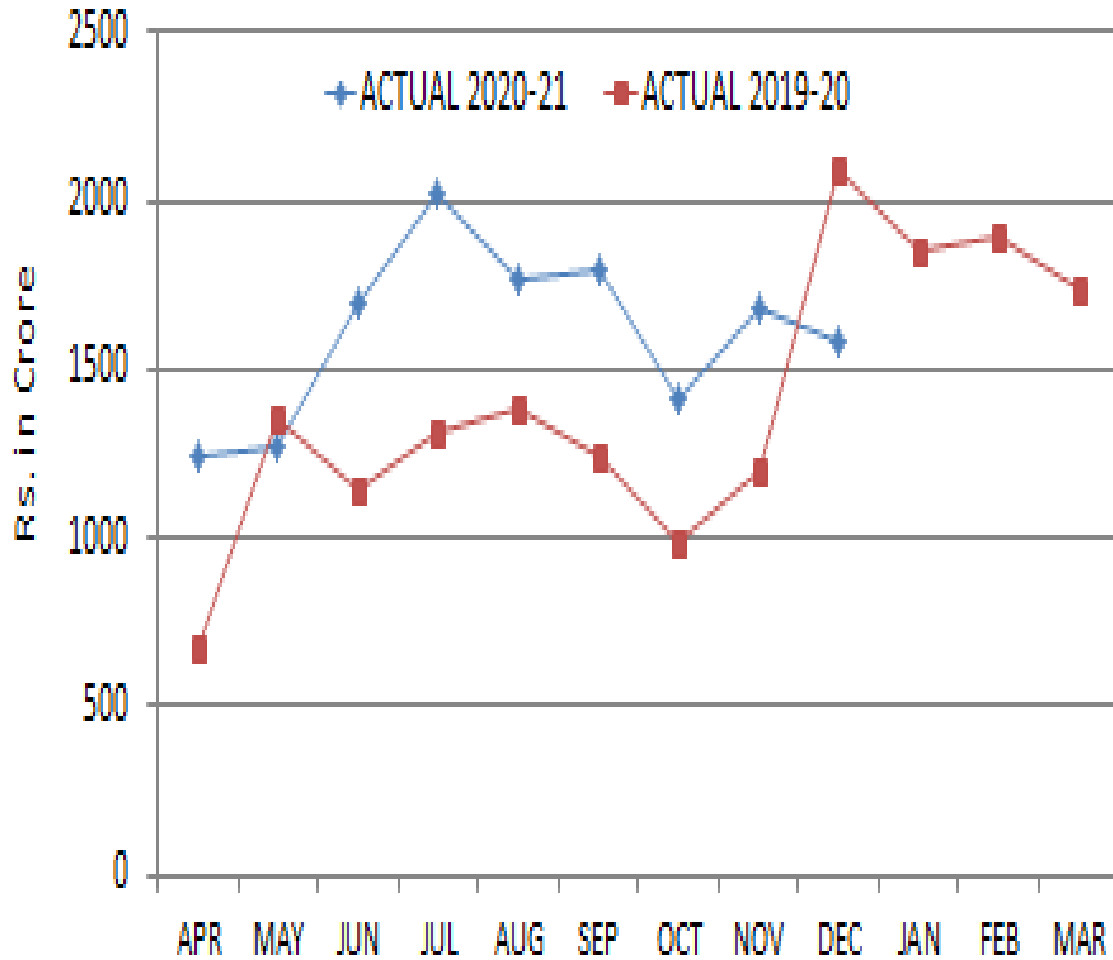

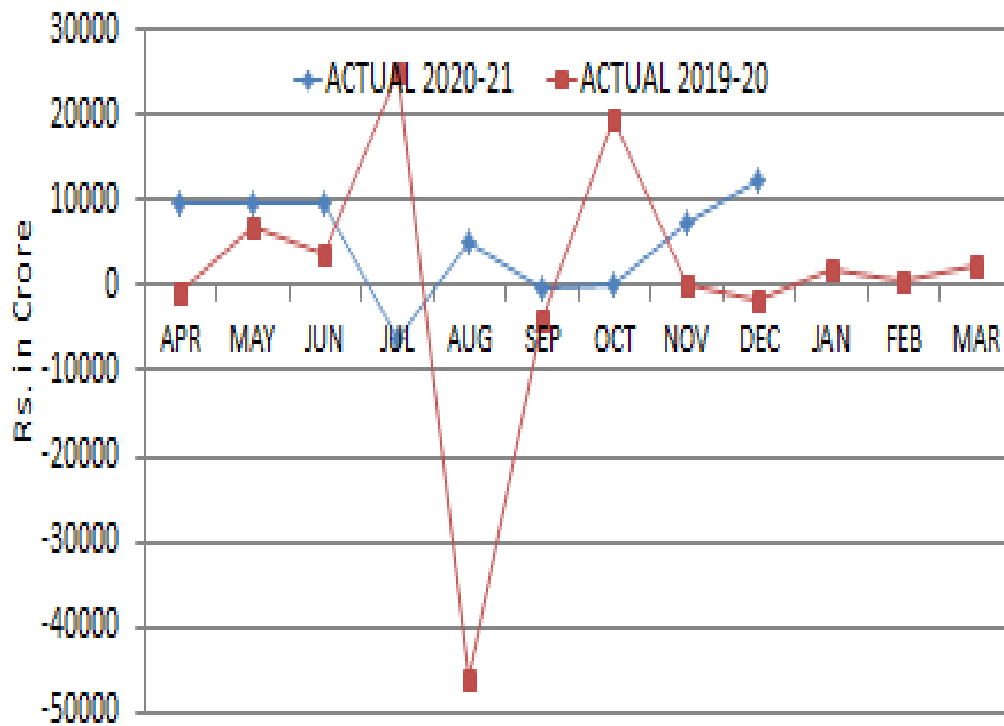

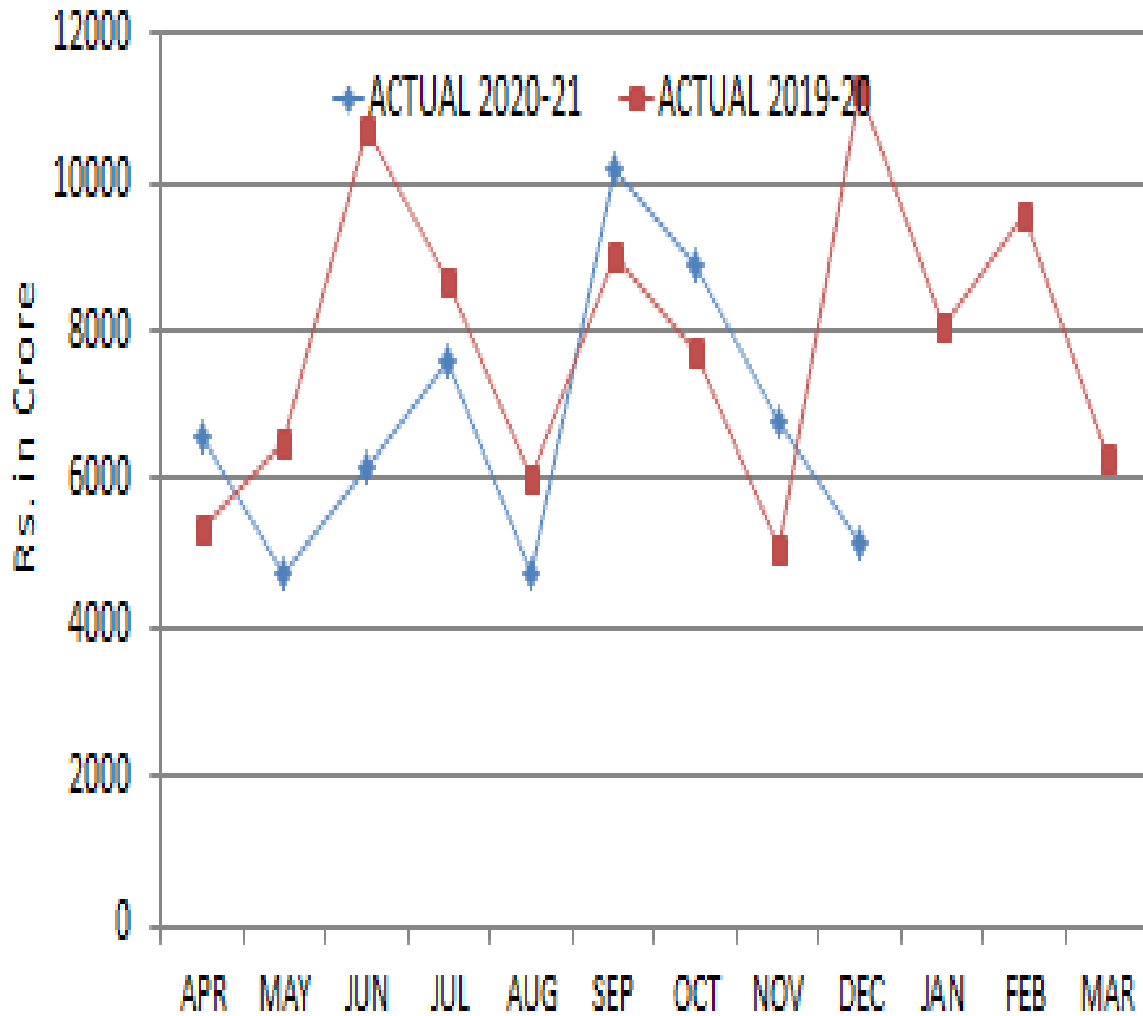


## IGST (Net) Monthly Trends of Collection
