Subject: Revision of pension cases.



The data shows that in respect of Ministry of Finance (CBIC), of the 41,133 pension cases which needed to be revised, 39,722 have been revised so far. Even after a lapse of almost 07 years since the issue of Government directions in the matter, 1,411 pension cases are still pending for revision.
