

**Online Subscriber Registration Module
for NPS Employees through
Employee Information System**

Brief introduction:

Employee Information System (EIS) –Salary Module in PFMS has been successfully implemented and working in civil DDOs under Central Government Ministries/Departments. Since its inception, continuous effort has been made by this office to add new functionalities and enhancements in order to facilitate the DDOs for smooth functioning of the module. Additionally, the module is also being integrated with external entities for sharing of on-line data like License Fees details to Directorate of Estates, Employees data to Bhavishya (for pension) and to e-HRMS etc.

As part of further enhancement in the module, it has been decided to integrate the same with Central Recordkeeping Agency, NSDL for “Online Subscriber Registration for PRAN generation” for new recruits. After this integration, the new employee can fill up the registration form online through his/her PFMS login ID and submit it to DDO, who will further verify the details and submit it to PAO/CDDO. After verification at PAO/CDDO level, a provisional PRAN will be issued immediately to the employee and the registration form details will be shared with CRA, NSDL. After acceptance of registration form by CRA, NSDL, the PRAN will become active and updated in Employees’ Profile in EIS Salary Module. It may be noted that PAN, Mobile Number and Govt. Email ID is mandatory while creating employee data in EIS Salary Module.

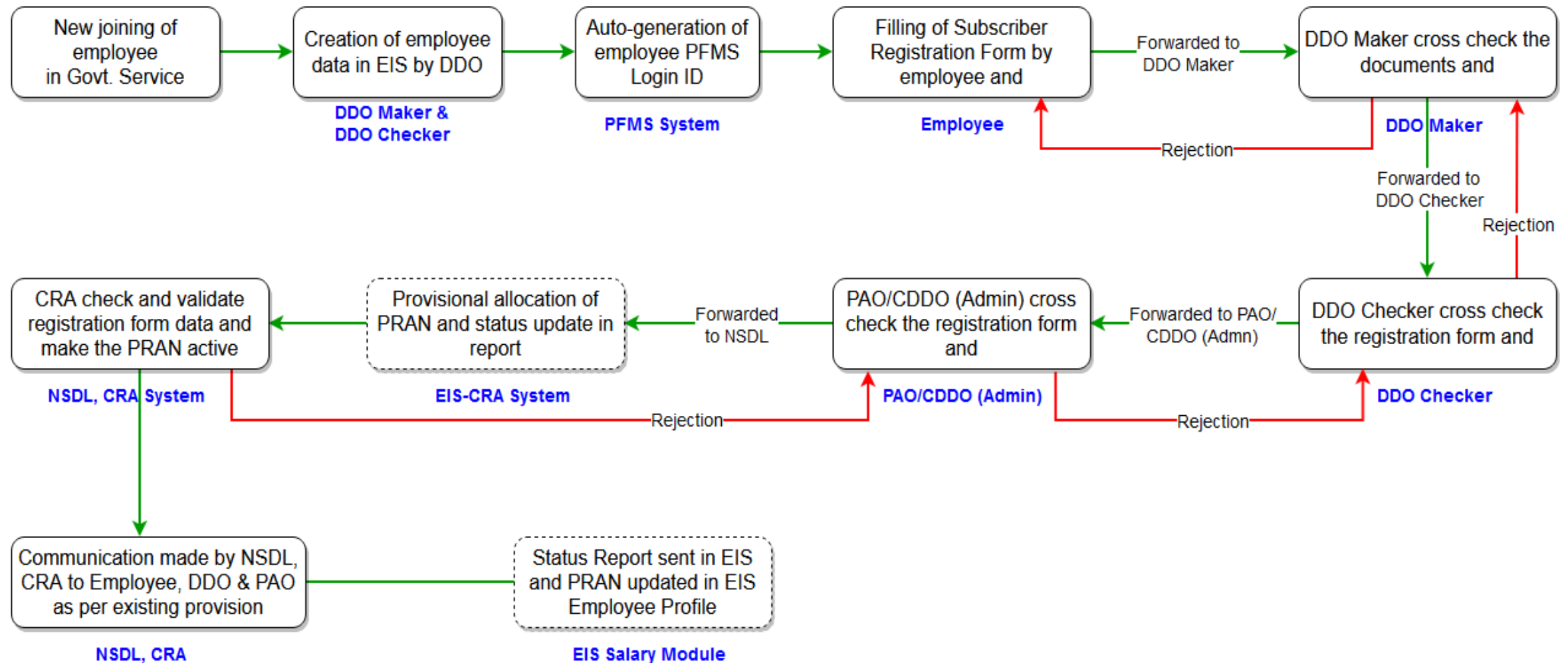

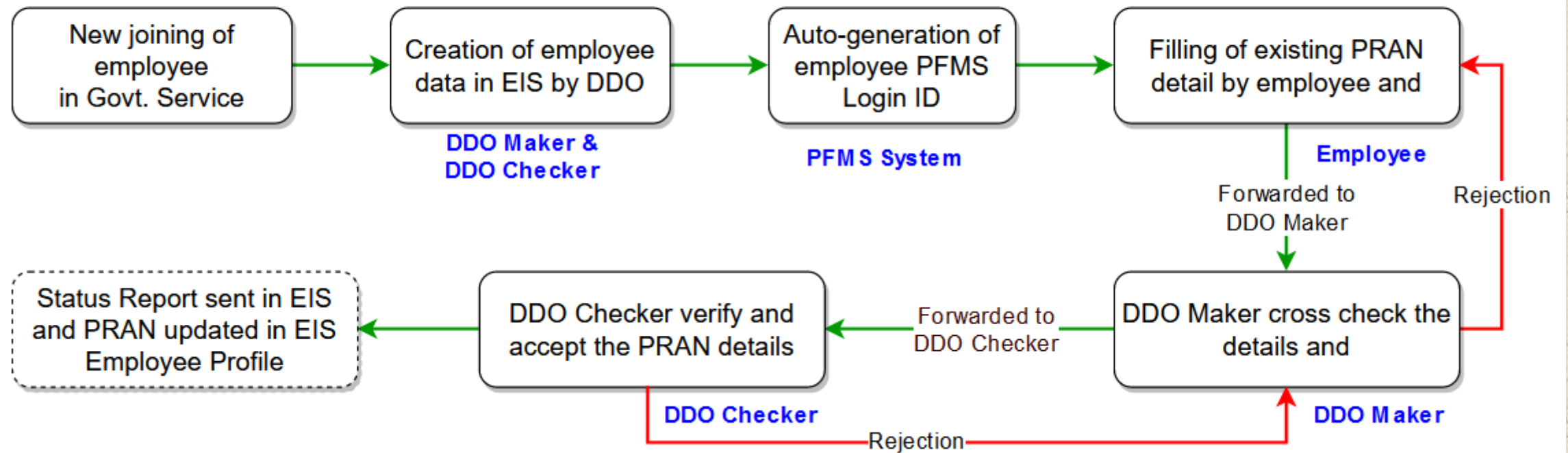

INSTRUCTIONS FOR FILLING THE SUBSCRIBER REGISTRATION FORM

A. Personal Details

1. Important: If your name details or any other pre-filled details (non-editable) are not correct, please contact your DDO Office for correction first. Only after correction, you may proceed to fill this registration form for PRAN allotment.
2. This Form is applicable only for Resident Indians. There is a separate Form for Non Resident Indians & Overseas Citizen of India.
3. Statement of Transaction Language is the "Language" in which CRA, NSDL will send your details of statement related to NPS contributions and investments in Pension Fund in future.

B. Contact Details

1. FATCA stands for Foreign Account Tax Compliance Act.
2. Correspondence address will be used by CRA, NSDL for any correspondence in future.

C. Other & Bank Details

1. Politically Exposed Person: Politically Exposed Persons' (PEPs) are individuals who are or have been entrusted with prominent public functions in a foreign country, for example heads of state or of the government, senior politicians, senior government, judicial or military officials, senior executives of state-owned corporations, important political party officials.
2. Subscriber's Bank Details: For Tier I account, bank details are mandatory and it should be supported by a documentary proof. Please attach a cancelled cheque containing Subscriber Name, Bank Name, Bank Account Number and IFS Code. If cheque is not available or cheque is not pre-printed with Subscriber name, a copy of bank passbook or bank statement or bank certificate or letter from Bank mentioning Subscriber Name, Bank Name, Bank Account No. and IFS Code should be submitted.

D. Pension Fund and Investment Options

1. At present, by default, the subscriber contributions will be allocated among 03 Pension Funds namely (i) LIC Pension Fund Limited (ii) SBI Pension Funds Pvt. Limited (iii) UTI Retirement Solutions Ltd. in the ratio as per direction of PFRDA. Further, the

Further, the provision to make available the options to select the choice of investment scheme at the registration level itself is under development and will be rolled out at the earliest.

E. Nomination Details

1. Subscriber can nominate a maximum of three nominees.
2. Subscriber cannot fill the same nominee details more than once.
3. Percentage share value for all the nominees must be integer. Decimals/Fractional values shall not be accepted in the nomination(s).
4. Sum of percentage share across all the nominees must be equal to 100. If sum of percentage is not equal to 100, entire nomination will be rejected.

F. Document Upload

1. Scanned copy of PAN Card and Cancelled Cheque in *.JPEG or *.JPG format are required to be uploaded. The size of these documents should be between 4 KB to 50 KB.

G. Photo-Signature Upload

1. Photo/Signature should be in *.JPG format. If your Photo/Signature image is in other format, please save it as in *.JPG format. Allowed size of Photo/Signature is between 4 KB to 12 KB.
2. The subscriber should not sign across the photograph. If there is any mark on the photograph such that it hinders the clear visibility of the face of the subscriber, the application shall not be accepted.

H. Form Submission (with Email OTP Verification)

1. Copies of all the documents submitted by the applicant should be self-attested and accompanied by originals for verification by the nodal office (DDO Office).
2. Name and Address of the applicant mentioned on the form, should match with the documentary proof submitted.
3. The registration form details can be downloaded in PDF file and should be checked thoroughly before submission to DDO.

- After acceptance of registration form by NSDL, the provisional PRAN will be marked as active by NSDL. The same PRAN will be then auto-updated in Employee Profile in EIS Salary Module.
- In case, the NSDL rejected the registration form due to any discrepancy, the user has to re-initiate the application from start and the provisional PRAN will be marked as defunct.
- After re-initiation of registration process, when submitted by PAO/CDDO to NSDL, new provisional PRAN will be allotted by system again.

- The allotted PRAN should be written on printed PRAN Application by PAO/CDDO(Admin).
- PAO/CDDO(Admin) should send the printed form alongwith necessary documents to NSDL, CRA, Mumbai (and not to any Facilitation Centre) during the pilot run or till further instructions issued in this regard.
