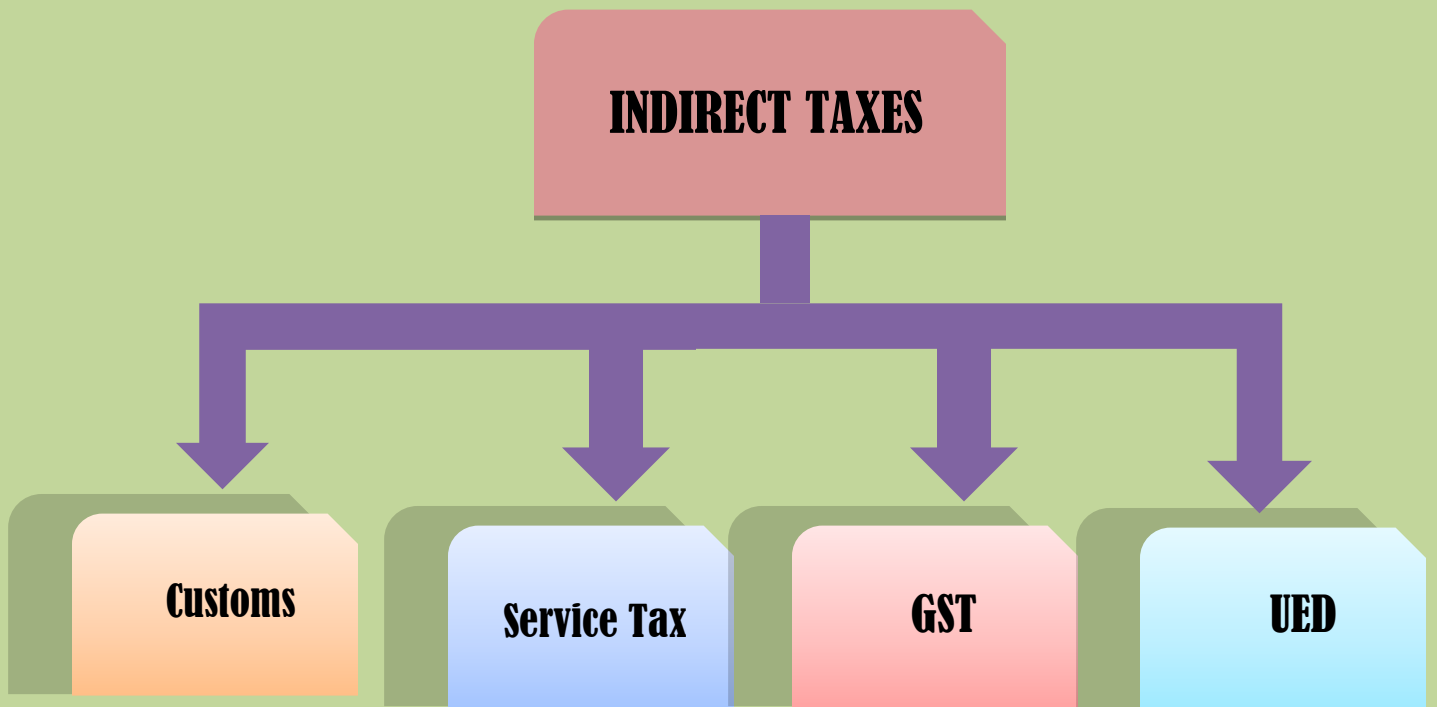

INDIRECT TAX COLLECTION

July, 2025

Executive Summary

Gross Collections

- Gross collection of Indirect Taxes (including GST) upto **July, 2025** is **Rs. 7,64,654.88 crore** in comparisons to **Rs. 7,17,858.12 crore** upto July in previous year, showing a growth of **6.52%**. Out of the Total Gross collection, the share of **CGST** is **Rs. 1,54,174.81 crore**, **UTGST (OT)** is **Rs. 124.74 crore**, **IGST** is **Rs. 4,01,852.35 crore**, **Compensation Cess** is **Rs. 51,880.73 crore**, **Custom Duty** is **Rs 71,960.71 crore**, **UED** is **Rs. 84,494.39crore** and **Service Tax** is **Rs. 167.15 crore**.

Net Collections (Total)

- Net collection upto **July, 2025** is **Rs. 5,18,696.73 crore** as compared to **Rs. 4,85,147.36 crore** upto July in previous year showing a growth of **6.92%**. The net collection is **29.89%** of the B.E. of **Rs. 17,35,100 crore**.

Custom Duty (Net)

- Net collection upto **July, 2025** is **Rs. 60,525.04 crore** which is **25.22% of B.E.**

Customs Duty drawback and Refund

- The Custom duty drawback & Refund payments upto **July, 2025** are **Rs. 11,435.67 crore**. (15.89% of Gross Collections)

Union Excise Duty (Net)

- Net collection of Excise Duty upto **July, 2025** is **Rs. 83,963.08 crore** which is **26.49%** of **B.E.**

Union Excise Duty Refund

- The UED Refund payments upto **July, 2025** are **Rs. 531.31 crore**. (0.63 % of Gross Collections)

Service-Tax (Net)

- Net collection of Service Tax **upto July, 2025** is **Rs. -168.51 crore** which is **-168.51% of B.E.**

Service Tax Refund

- The Service Tax Refund payments **upto July, 2025** are **Rs. 335.66 crore.** (200.81% of Gross Collections)

CGST (Net)

- Net Collection of CGST **upto July, 2025** is **Rs. 3,11,624.78 crore.** It includes the share of regular Settlements and Advance Apportionment from IGST, added through book adjustments.

UTGST (OT) (Net)

- Net Collection of UTGST (OT) **upto July, 2025** is **Rs. 540.38 crore.**

IGST (Net)

- Net collection of IGST **upto July, 2025** is **Rs. 11,907.11 crore.** This is after Refunds and monthly regular settlements as well as Advance Apportionments.

Compensation Cess (Net)

- Net (after Refund) collection of Compensation Cess **upto July, 2025** is **Rs. 50,304.85 crore.**

Refund of GST

- **An amount of Rs. 90,187.81 crore** has been paid as GST Refund upto July, 2025 with following details:

○ CGST:	Rs. 14,766.75 crore
○ UTGST (OT)	Rs. 0.00 crore
○ IGST:	Rs. 73,845.18 crore
○ Comp. Cess:	Rs. 1,575.88 crore

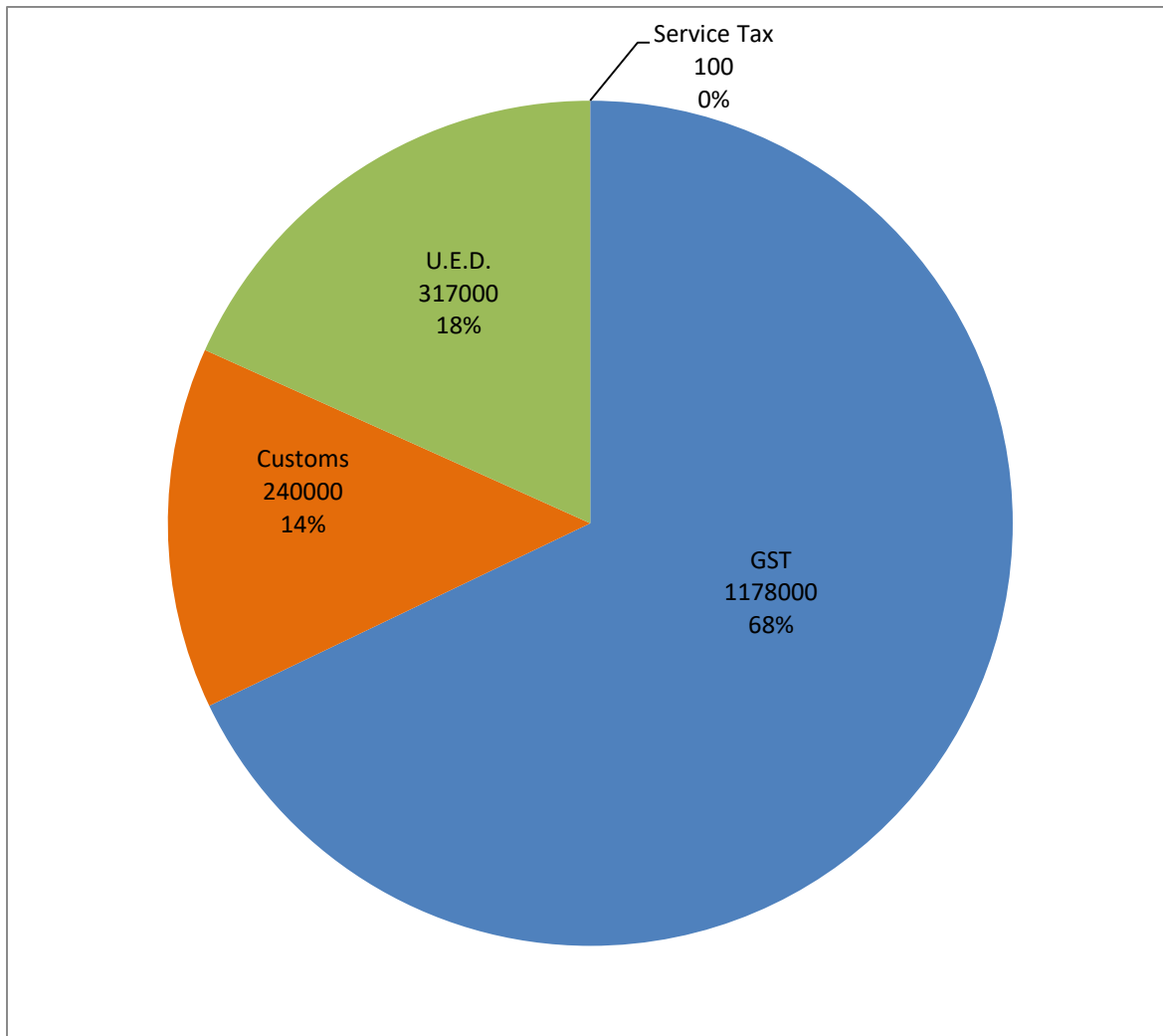

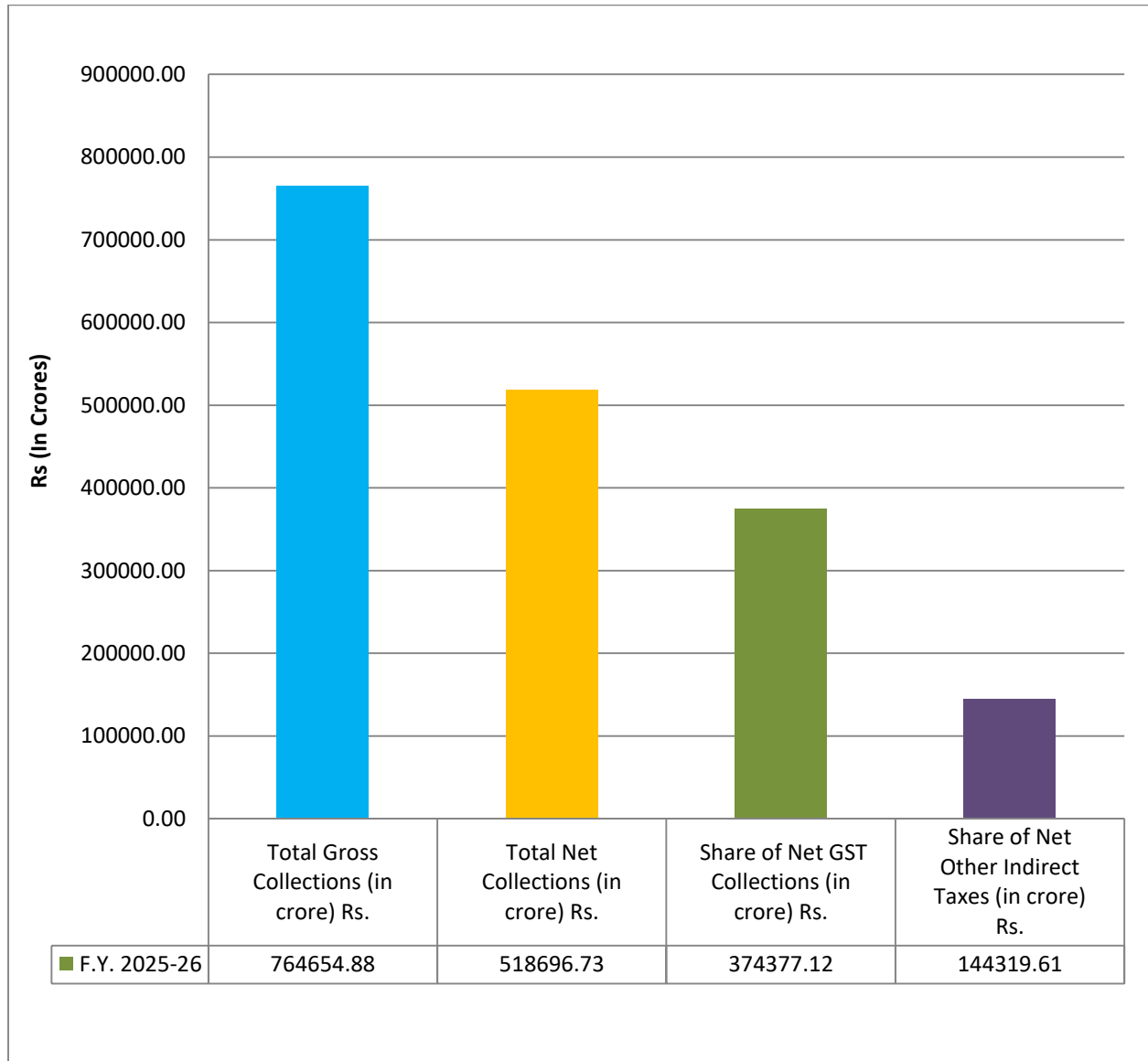

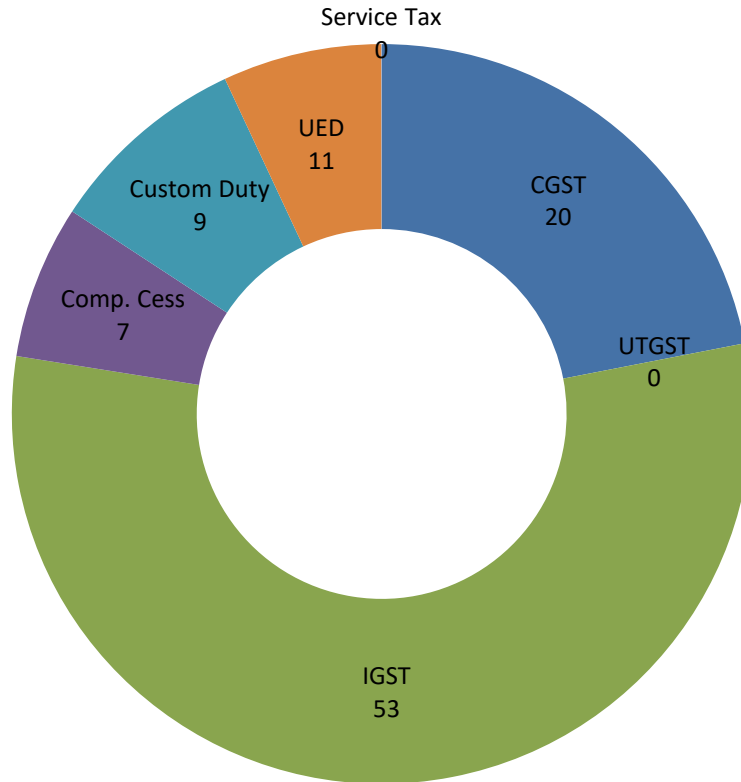
Cumulative Collections upto July, 2025

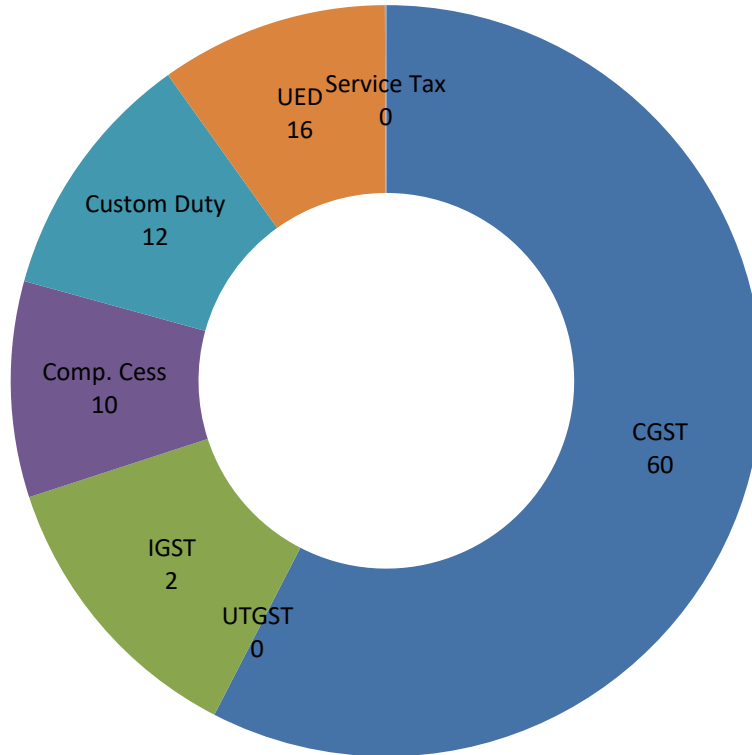
Gross Collection (in Percentage)

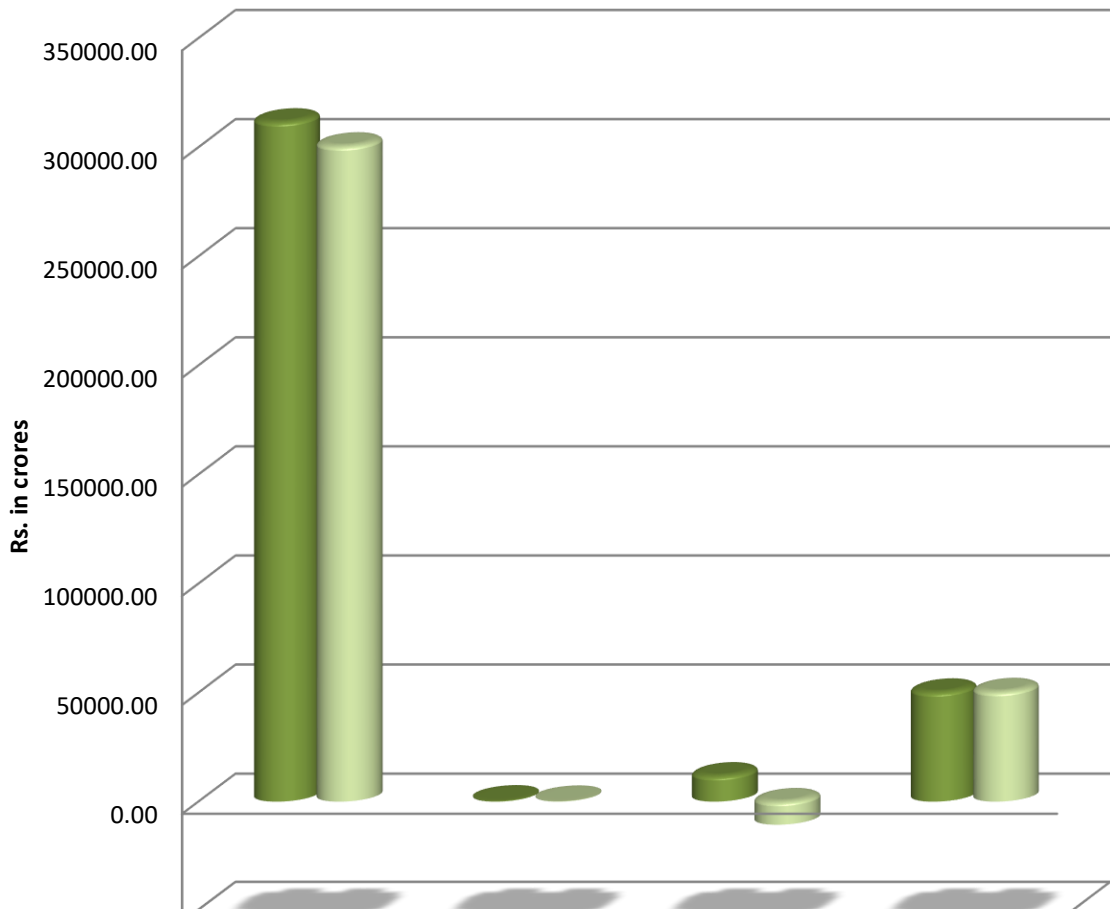

Net Collection (in Percentage)



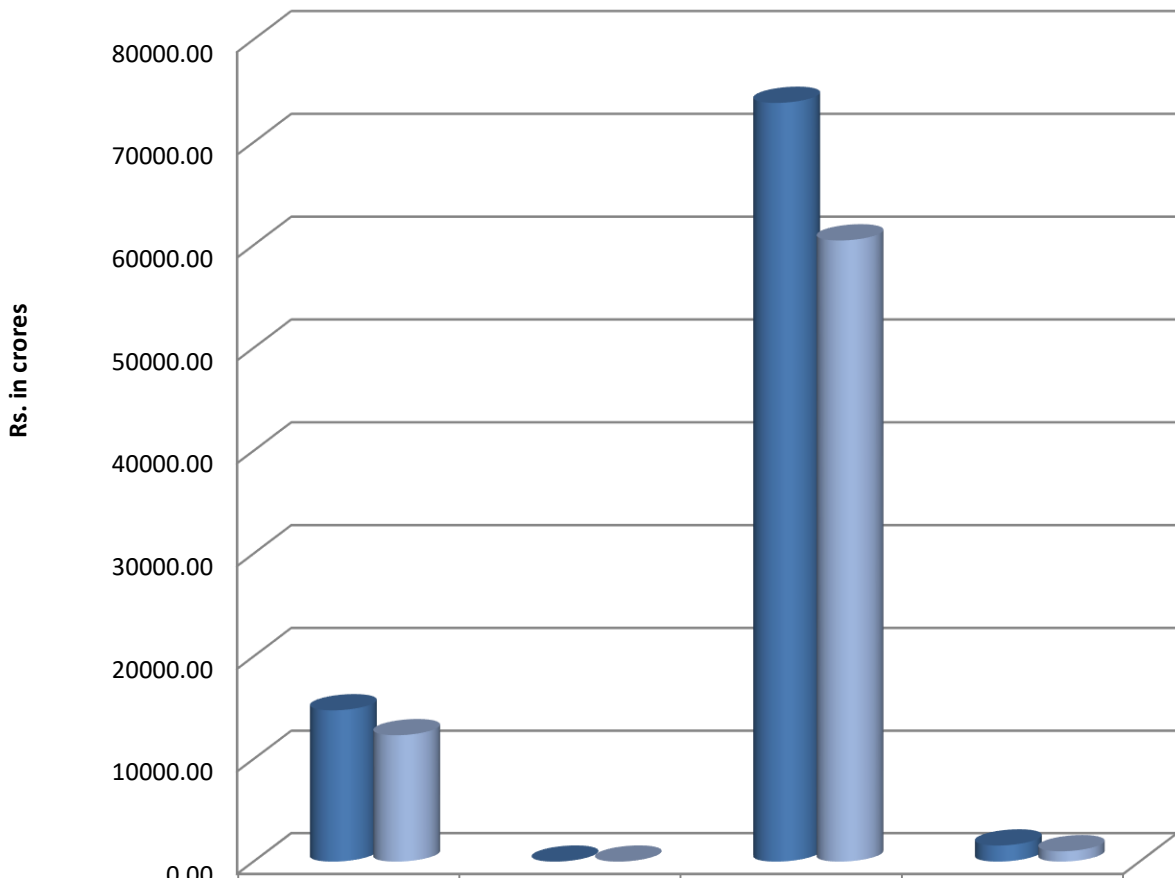

GST Net Collections upto July, 2025



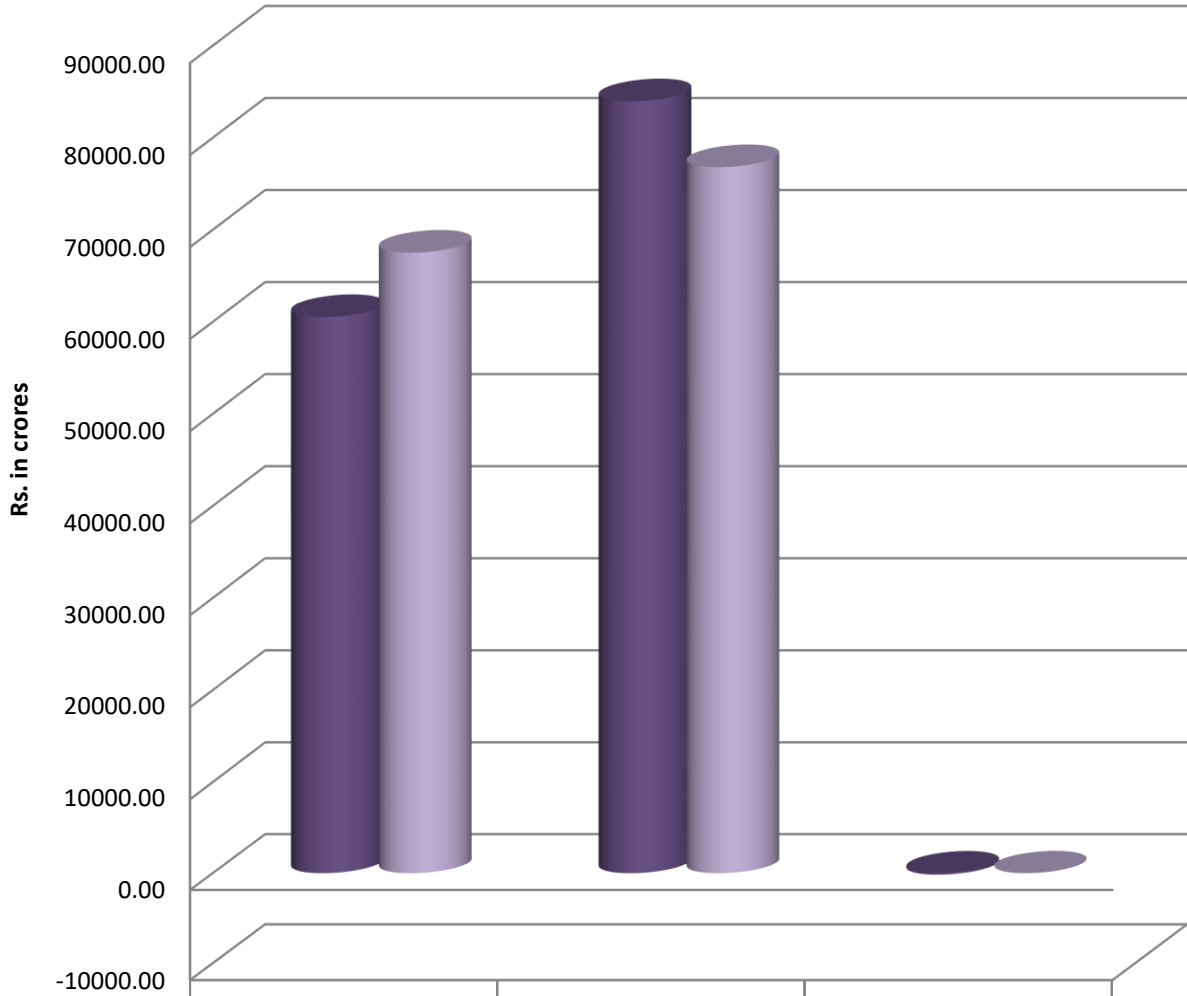

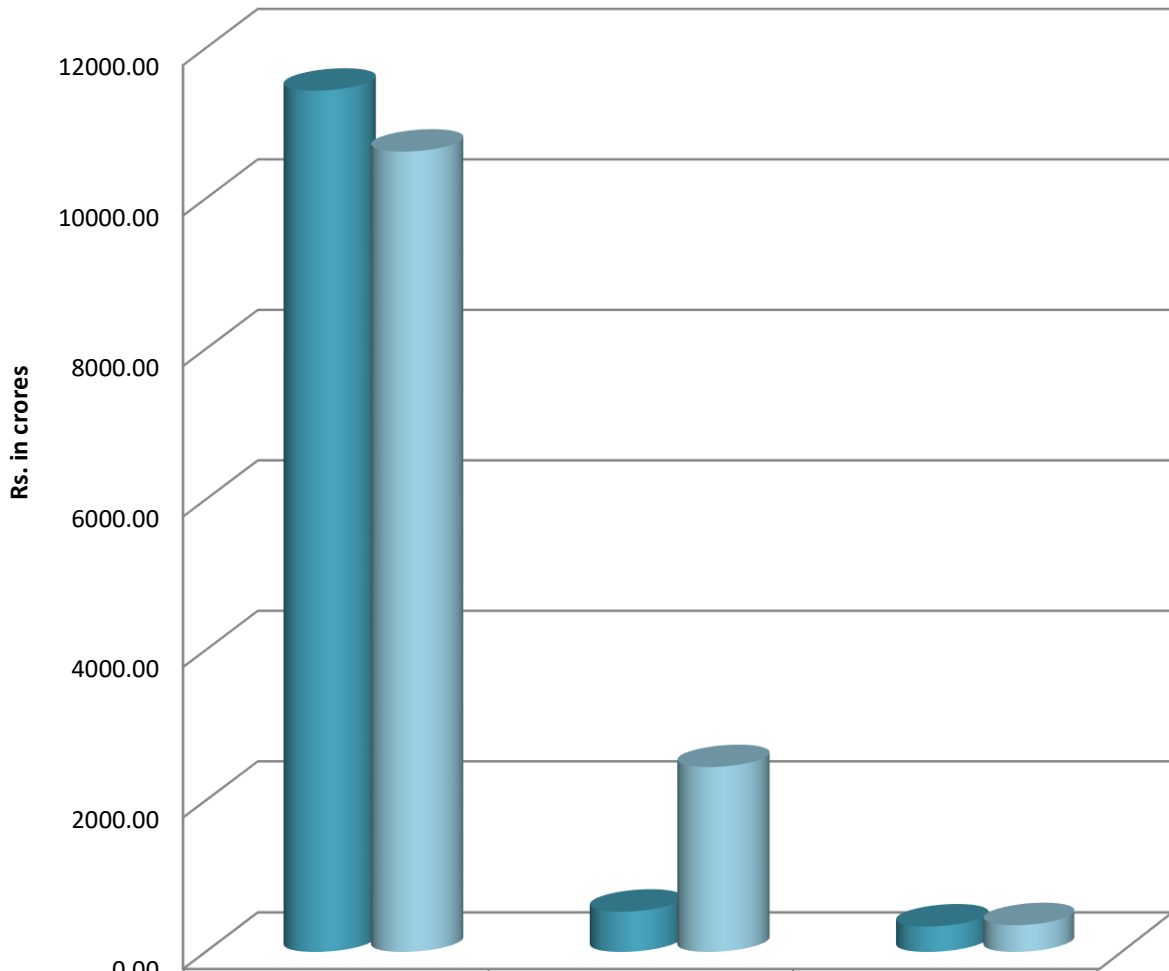

Non GST Net Collections upto July, 2025



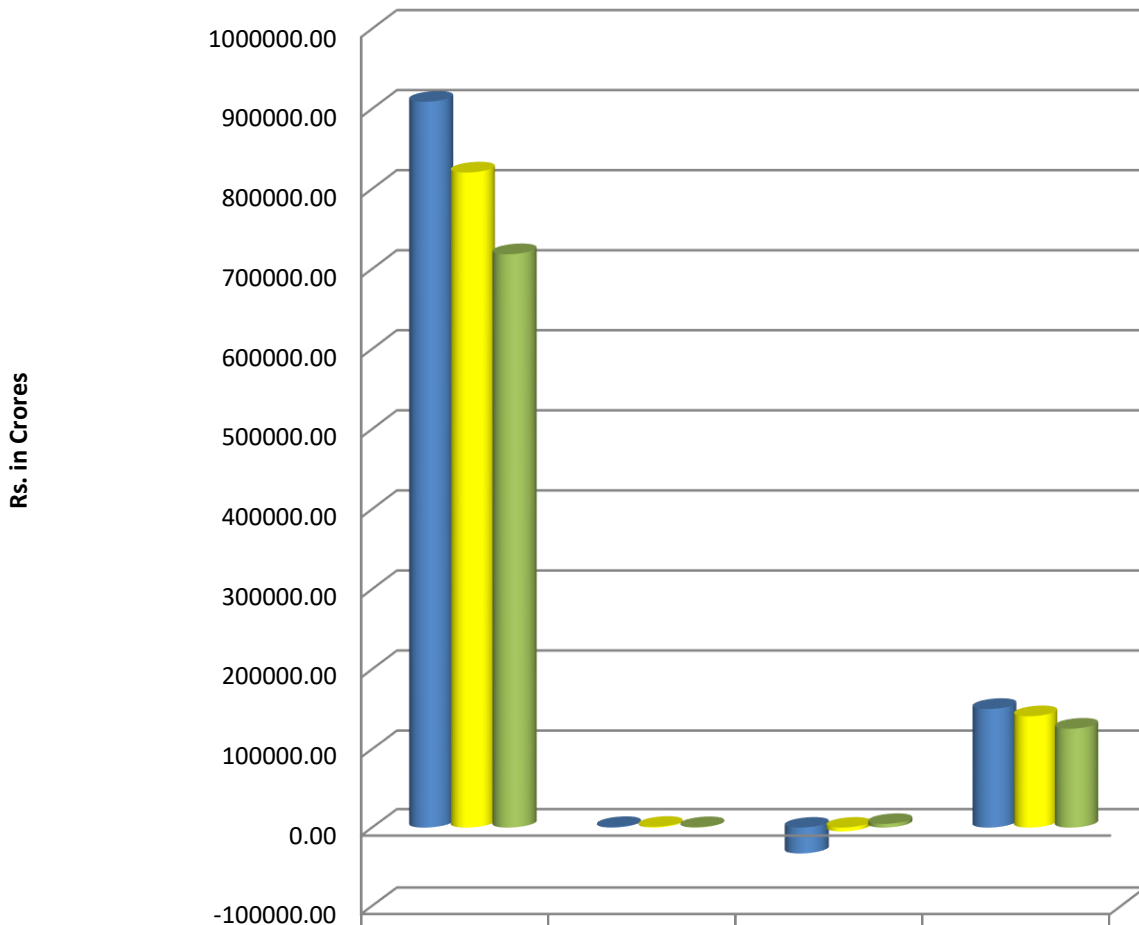

Non GST Refunds upto July, 2025



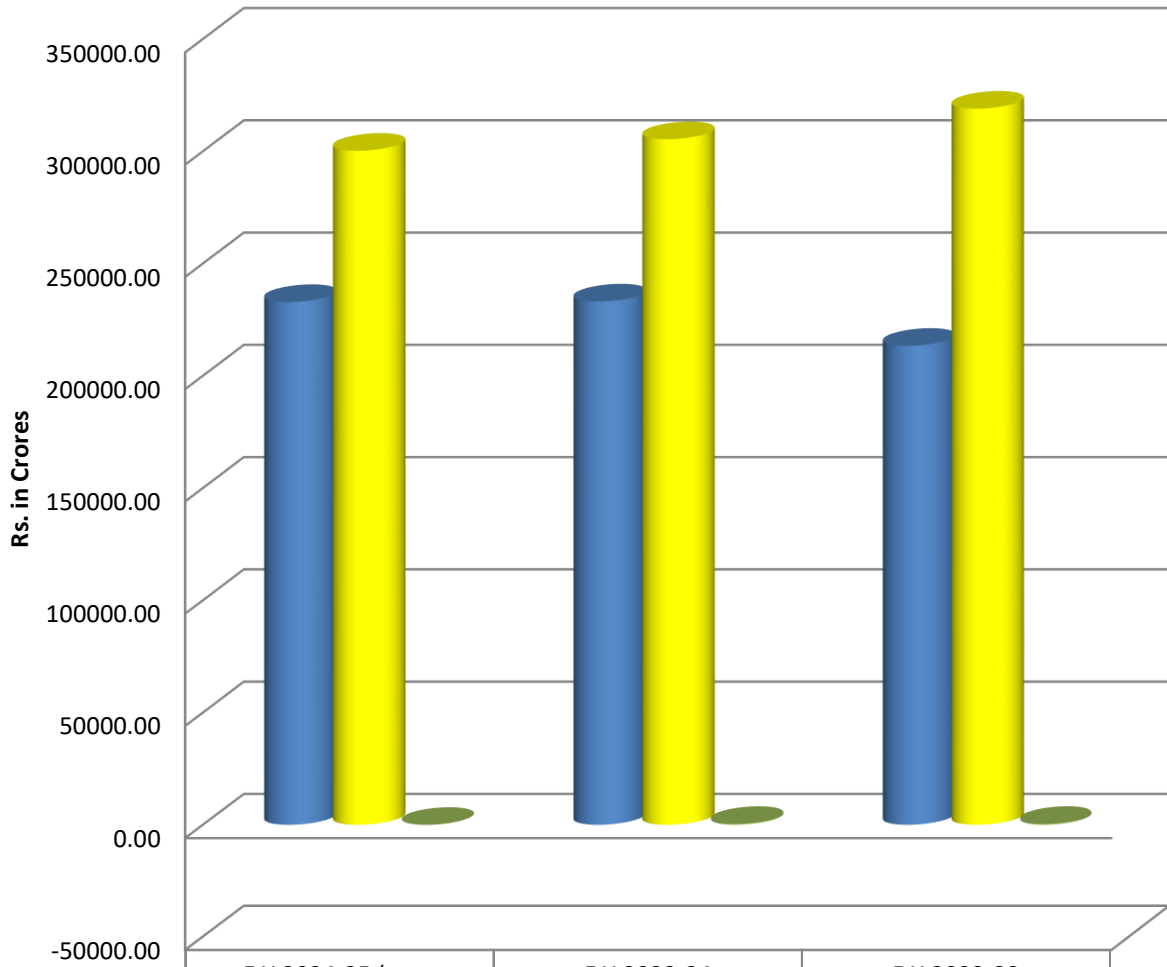

Non GST Net Collection Comparision of Last Three Years



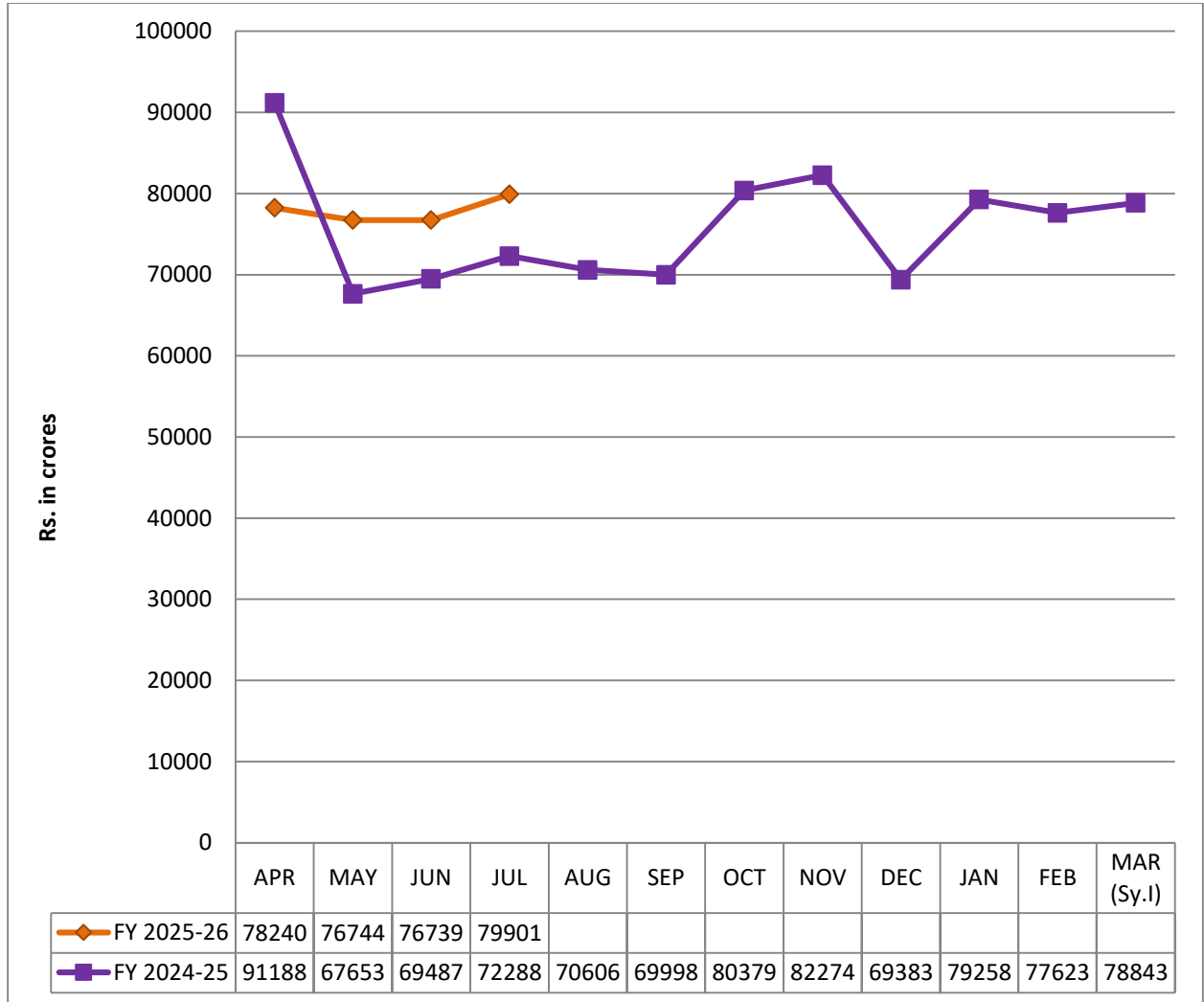

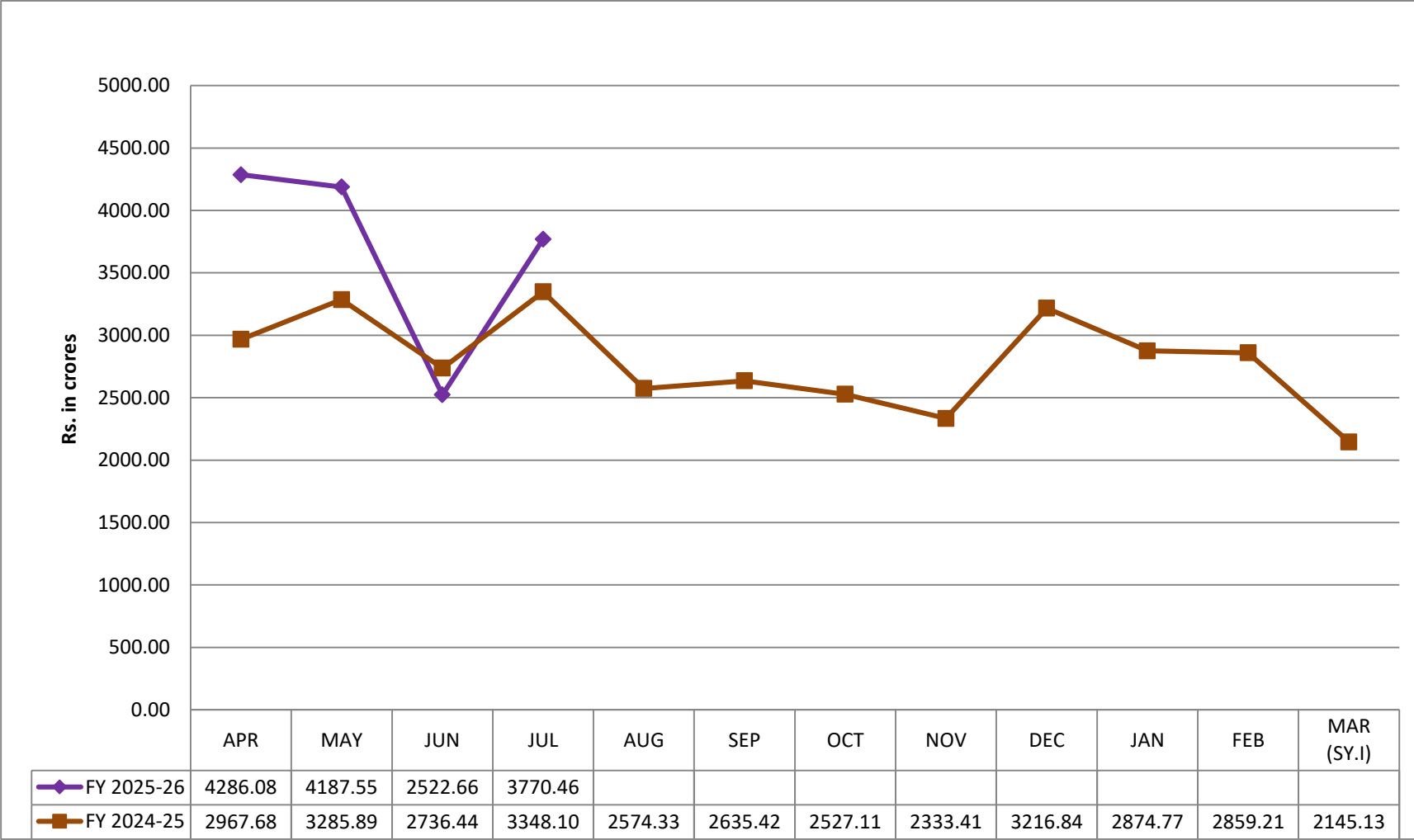

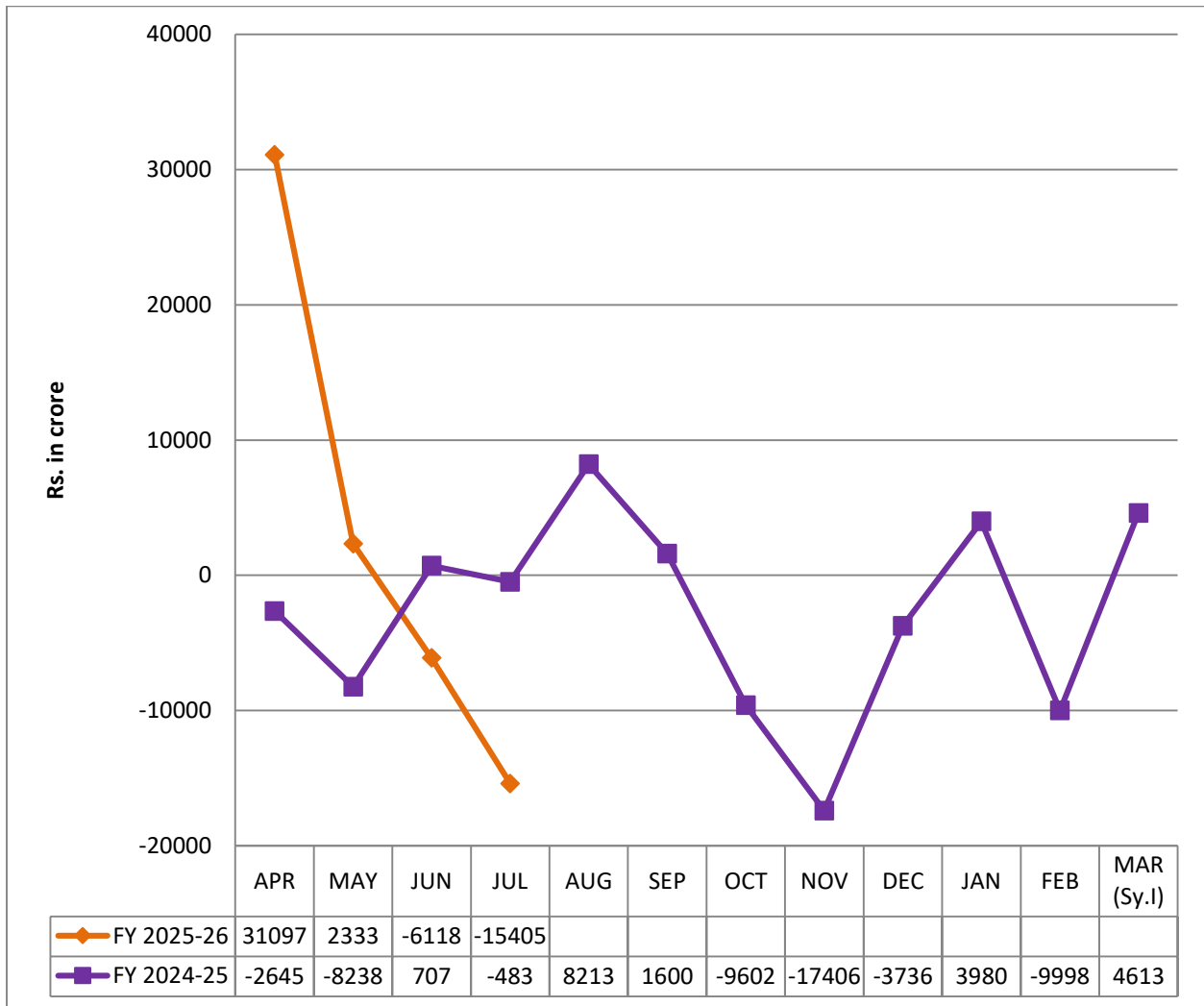

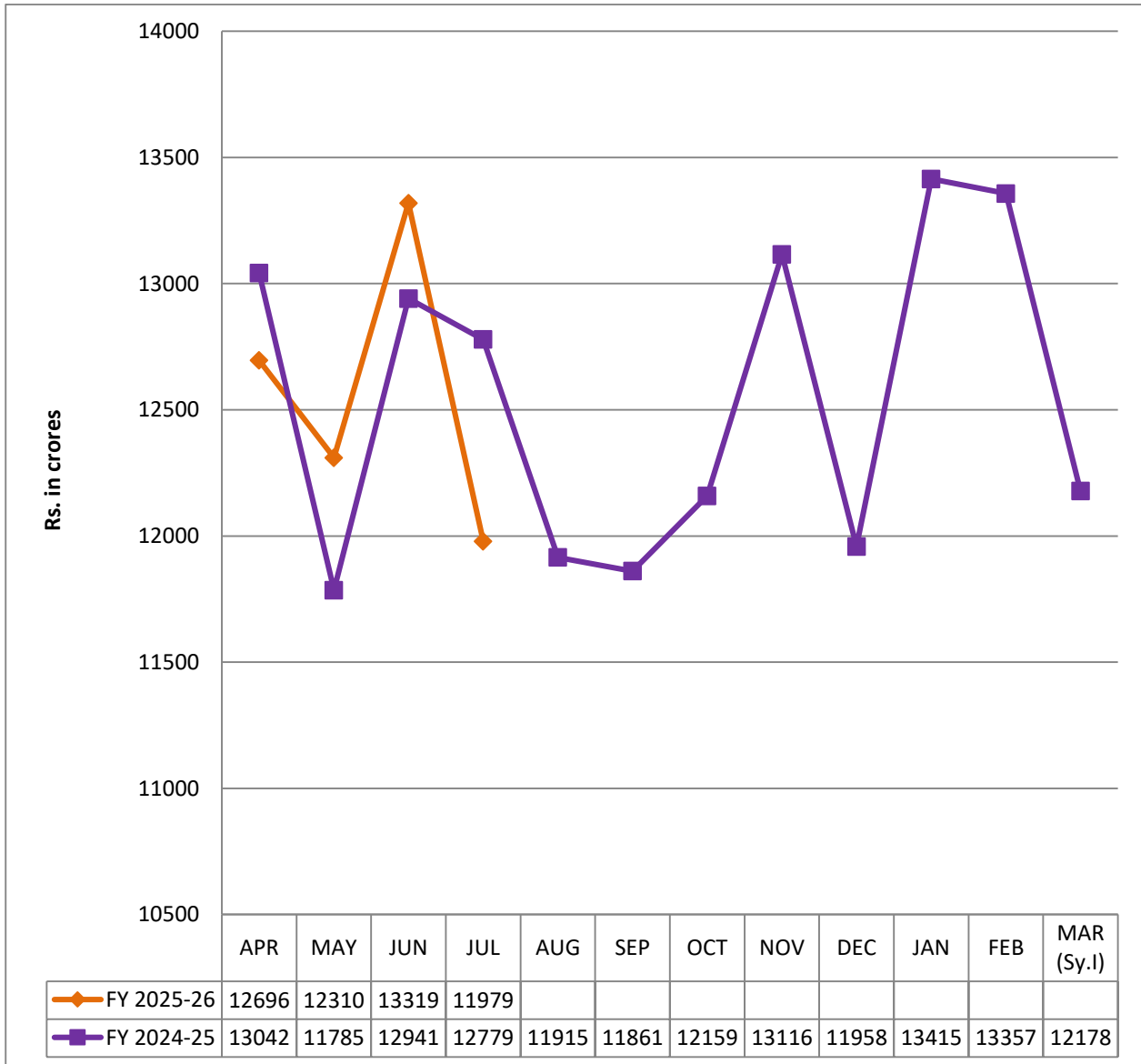

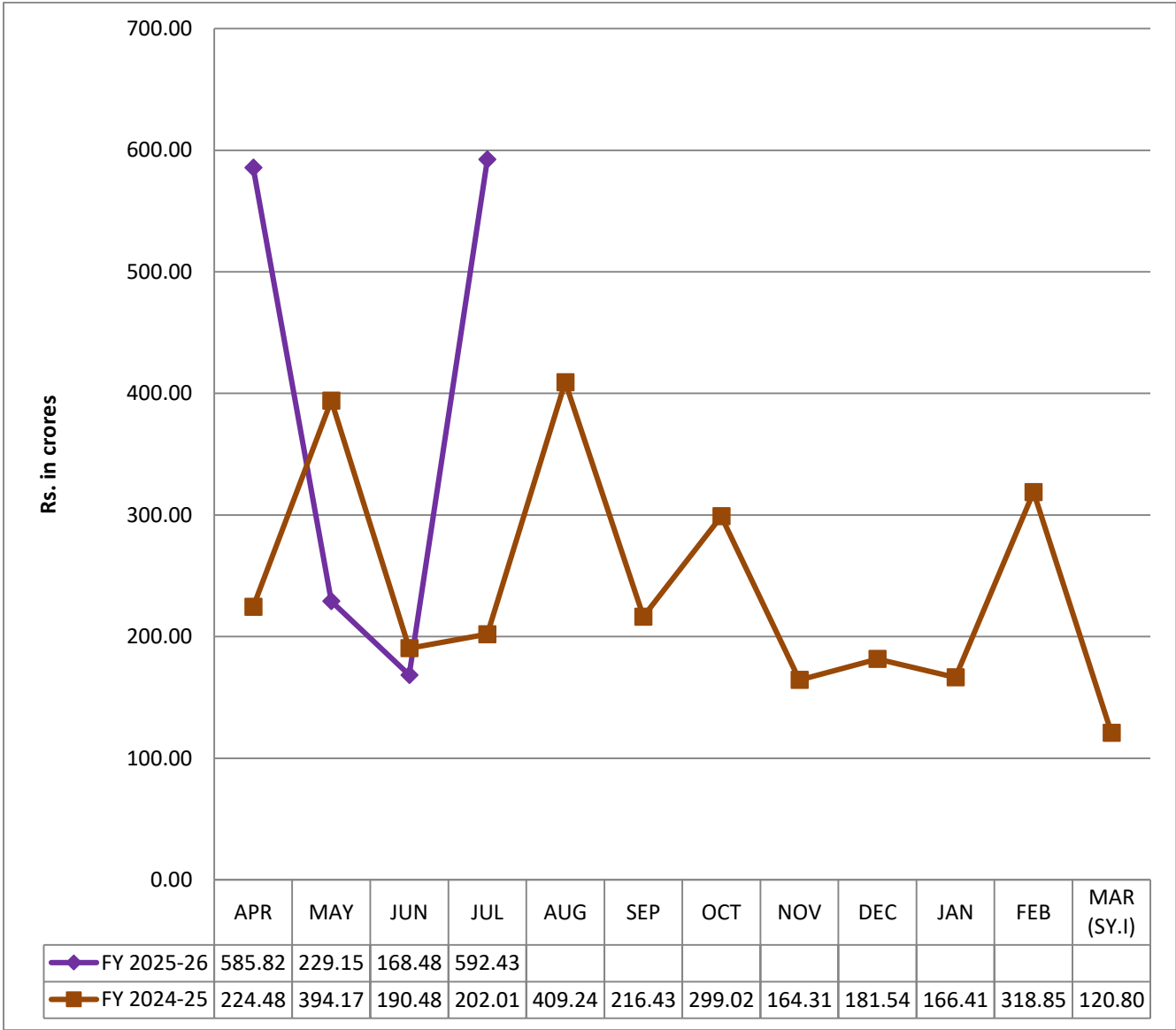

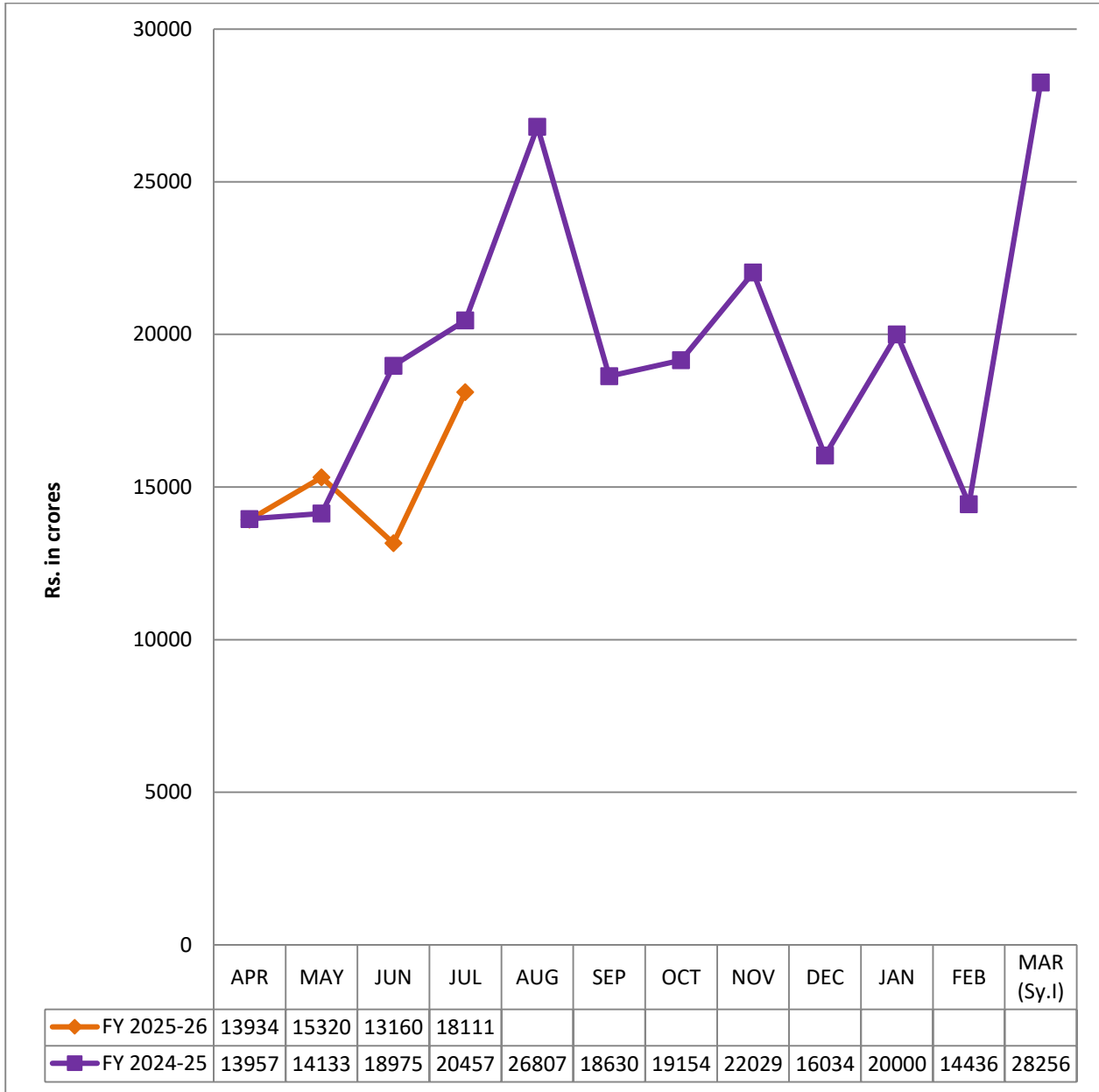

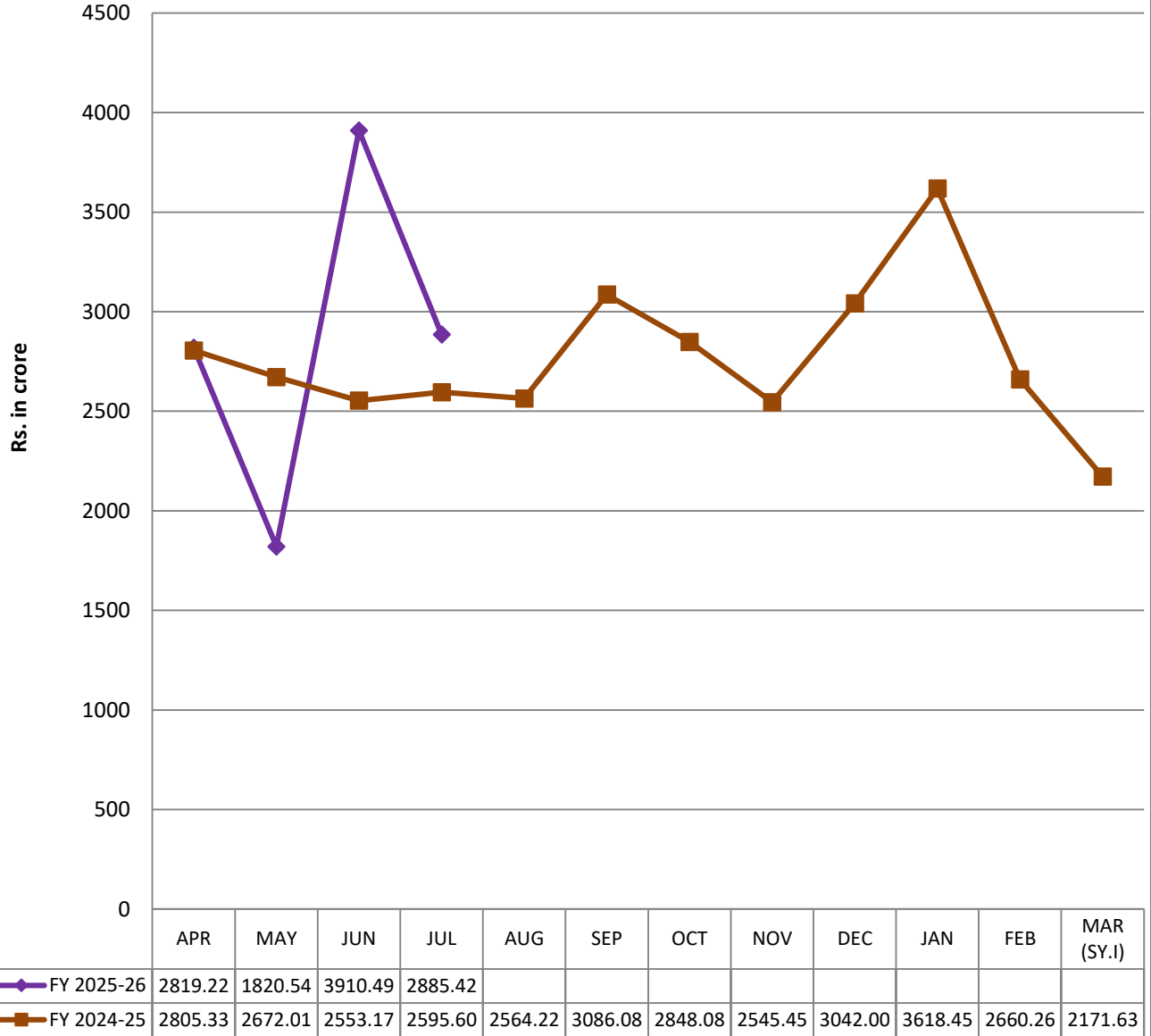

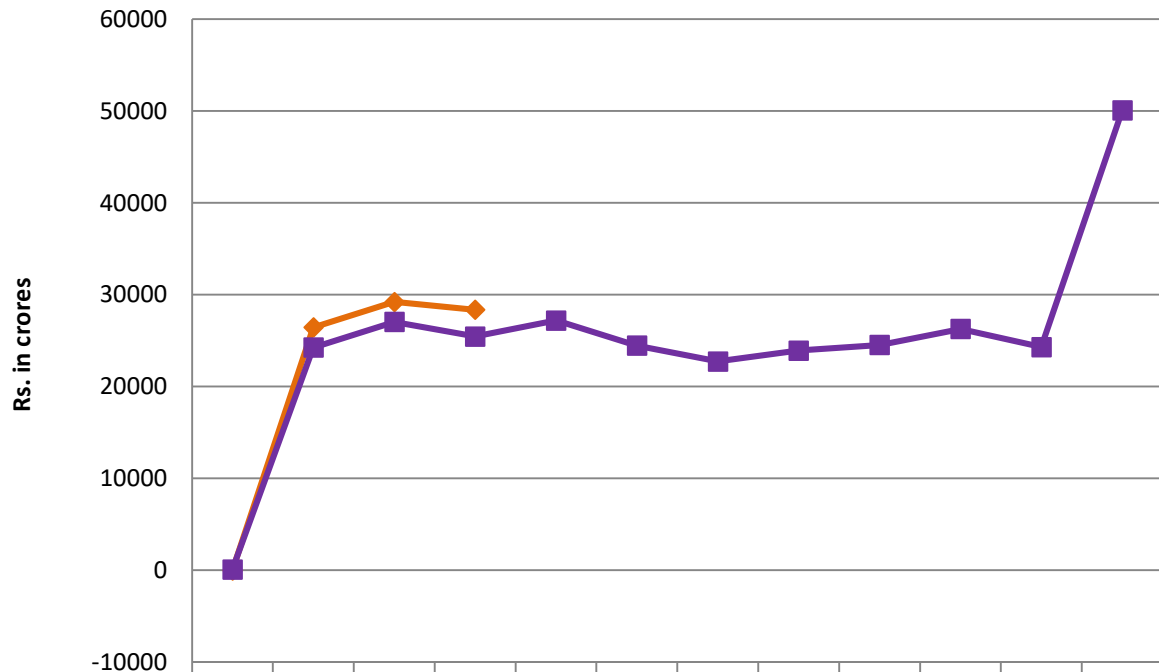

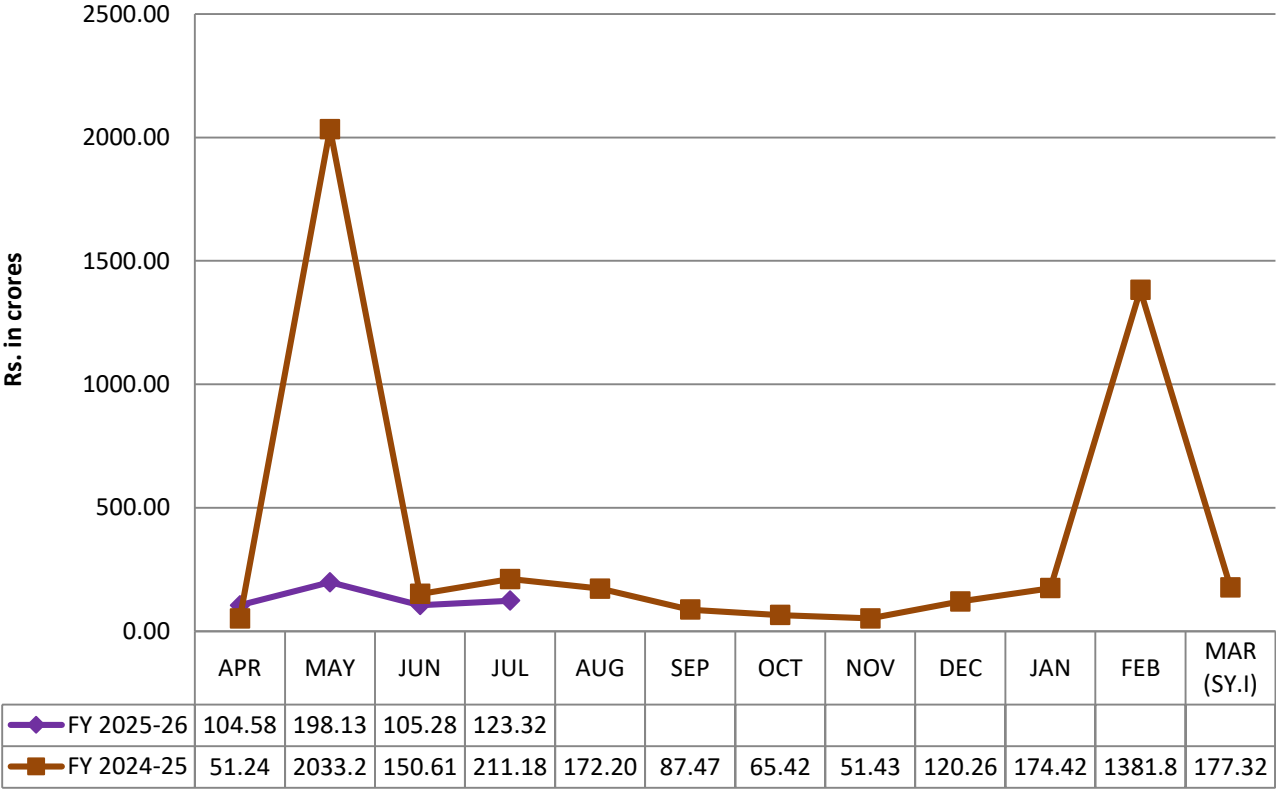

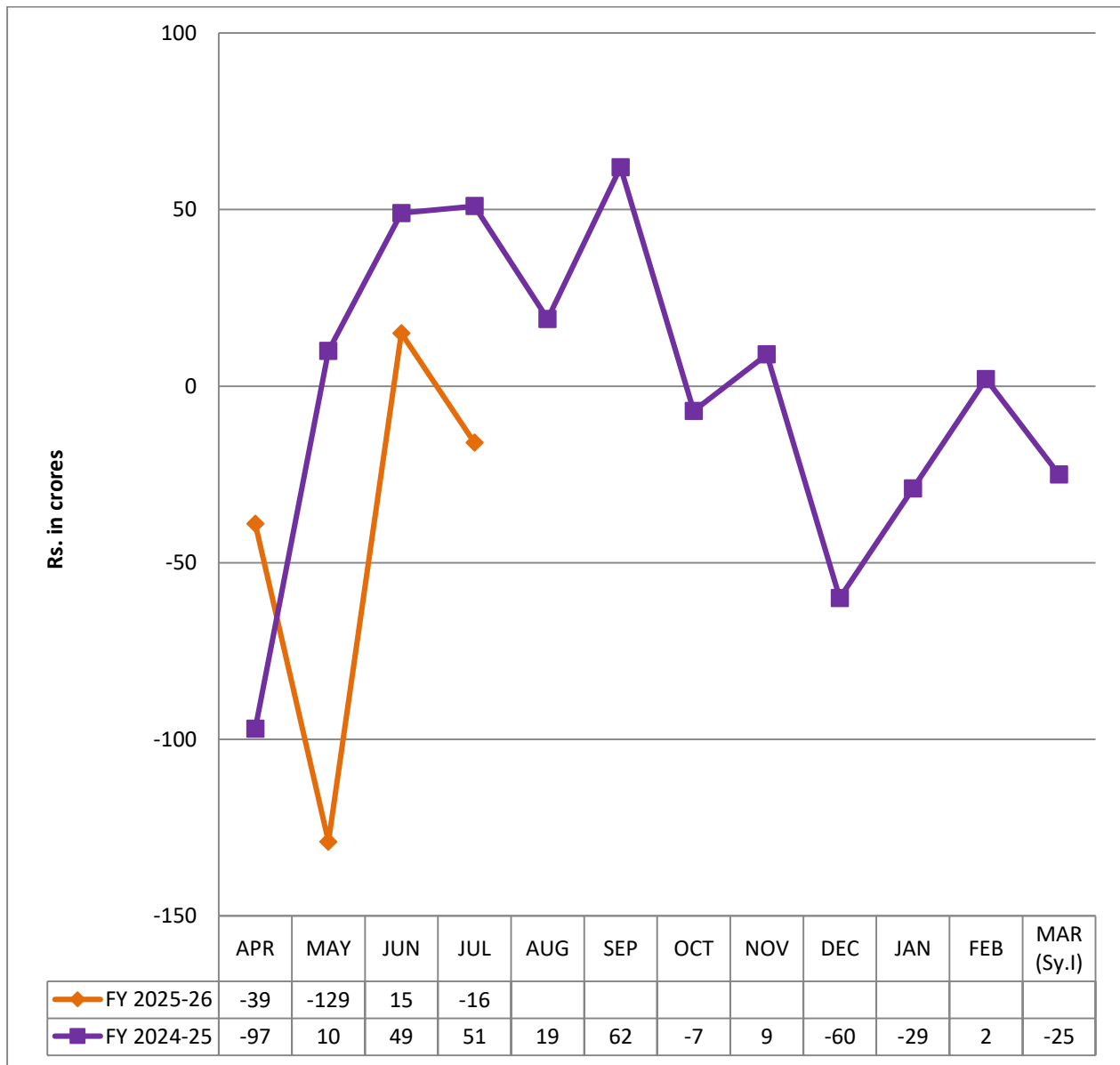

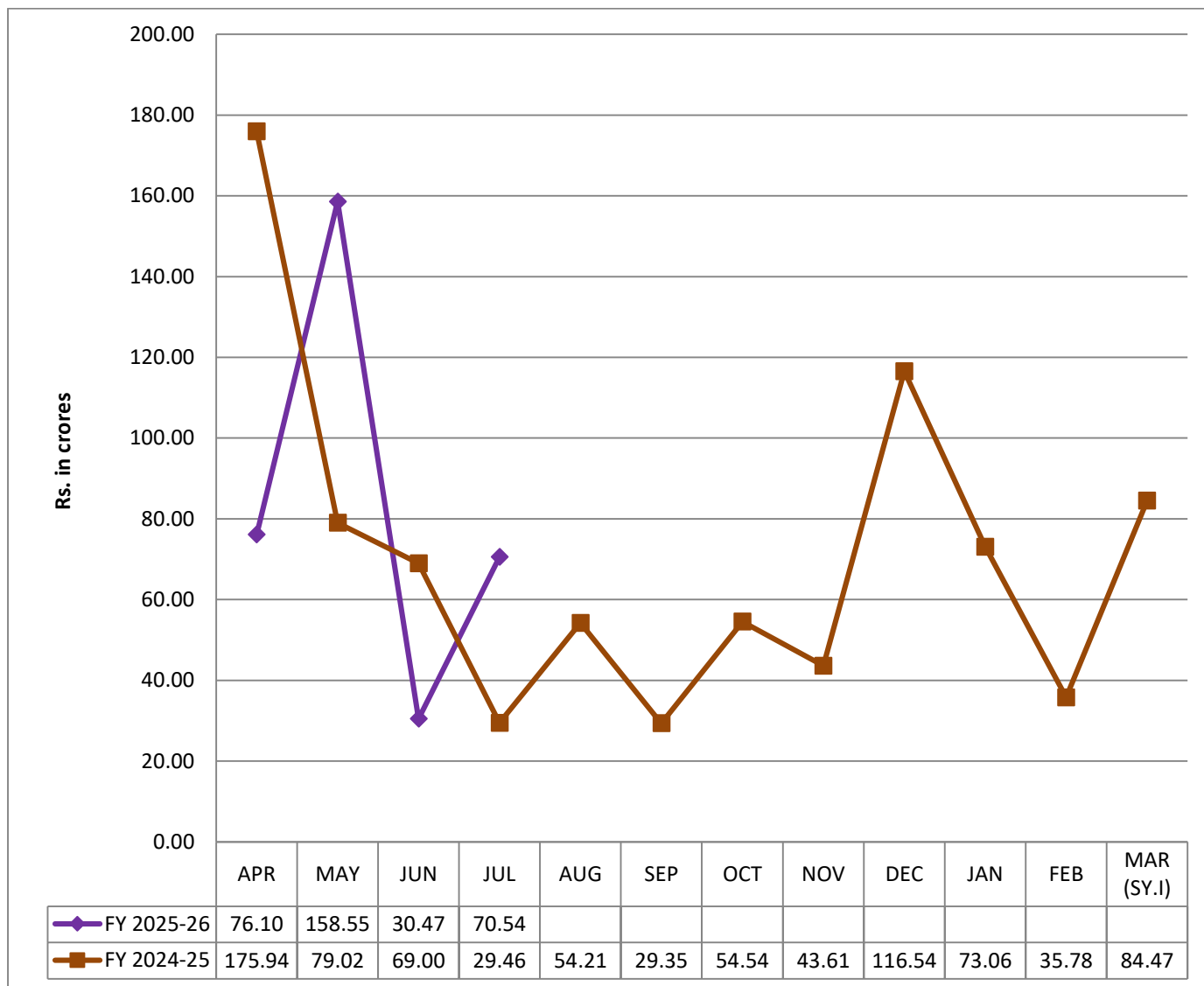
