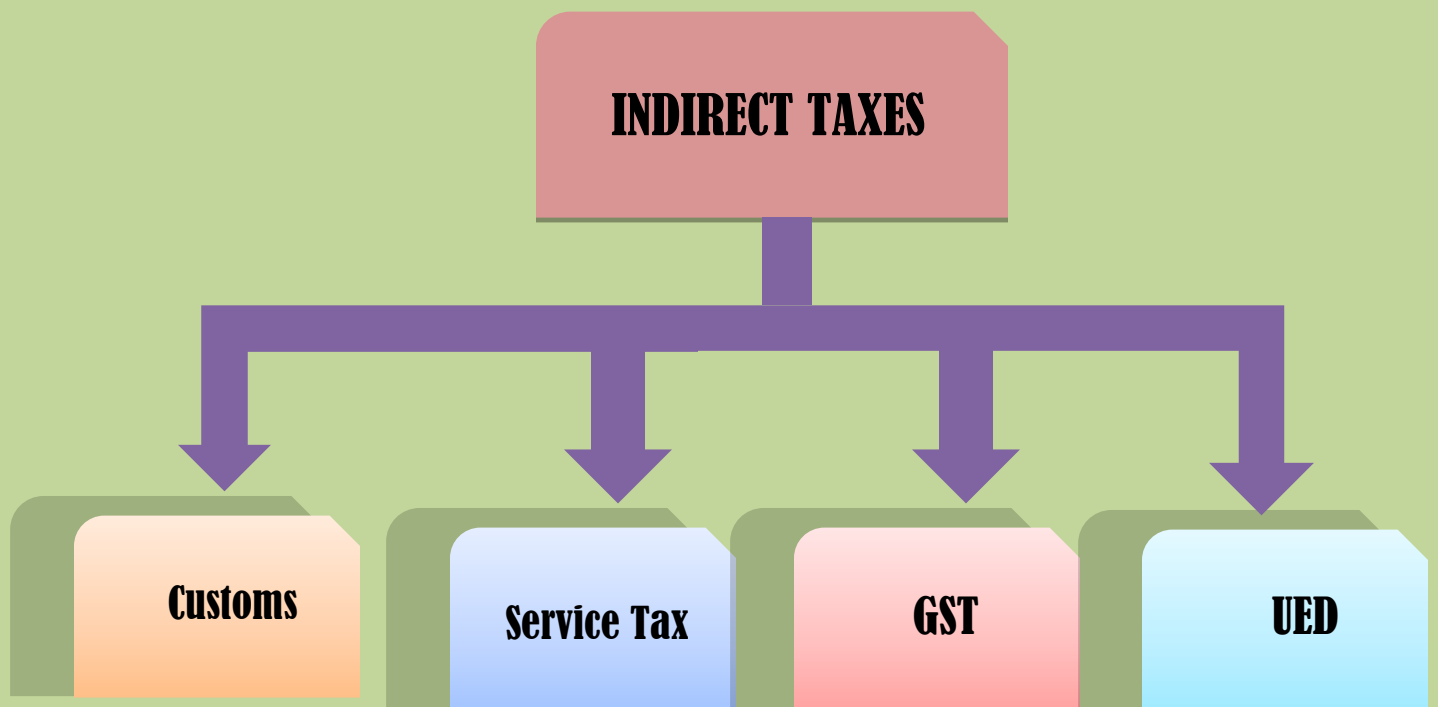

March (Final), 2024

Executive Summary

Gross Collections

- Gross collection of Indirect Taxes (including GST) upto **March (Final), 2024** is **Rs. 21,09,511.76 Crores** in comparisons to **Rs. 19,62,164.96 Crores** upto March (Final) in previous year, showing a growth of **7.51%**. Out of the Total Gross collection, the share of **CGST** is **Rs. 3,73,486.55 Crores**, **UTGST (OT)** is **Rs. 231.10 Crores**, **IGST** is **Rs. 10,22,946.17 Crores**, **Compensation Cess** is **Rs. 1,43,795.60 Crores**, **Custom Duty** is **Rs 2,61,371.63 Crores**, **UED** is **Rs. 3,06,591.36 Crores** and **Service Tax** is **Rs. 1,089.35 Crores**.

Net Collections (Total)

- Net collection upto **March (Final), 2024** is **Rs. 14,97,226.07 Crores** as compared to **Rs. 13,82,644.70 Crores** upto March (Final) in previous year showing a growth of **8.29%**. The net collection is **101.21%** of the R.E. of **Rs. 14,79,380 Crores**.

Custom Duty (Net)

- Net collection upto **March (Final), 2024** is **Rs. 2,33,118.97 Crores** which is **106.60% of R.E.**

Customs Duty drawback and Refund

- The Custom duty drawback & Refund payments upto **March (Final), 2024** are **Rs. 28,252.66 Crores**. (10.81% of Gross Collections)

Union Excise Duty (Net)

- Net collection of Excise Duty upto **March (Final), 2024** is **Rs. 3,05,362.18 Crores** which is **100.58% of R.E.**

Union Excise Duty Refund

- The UED Refund payments upto **March (Final), 2024** are **Rs. 1,229.18 Crores**. (0.40 % of Gross Collections)

Service-Tax (Net)

- Net collection of Service Tax **upto March (Final), 2024** is **Rs. 424.96 Crores** which is **84.99% of R.E.**

Service Tax Refund

- The Service Tax Refund payments **upto March (Final), 2024** are **Rs. 664.39 Crores.** (60.99% of Gross Collections)

CGST (Net)

- Net Collection of CGST **upto March (Final), 2024** is **Rs. 8,20,622.10 Crores.** It includes the share of regular Settlements and Advance Apportionment from IGST, added through book adjustments.

UTGST (OT) (Net)

- Net Collection of UTGST (OT) **upto March (Final), 2024** is **Rs. 1,112.13 Crores.**

IGST (Net)

- Net collection of IGST **upto March (Final), 2024** is **Rs. -4,850.43 Crores.** This is after Refunds and monthly regular settlements as well as Advance Apportionments.

Compensation Cess (Net)

- Net (after Refund) collection of Compensation Cess **upto March (Final), 2024** is **Rs. 1,41,436.16 Crores.**

Refund of GST

- An amount of **Rs. 1,80,003.55 Crores** has been paid as GST Refund upto March (Final), 2024 with following details:

○ CGST:	Rs. 30,903.14 Crores
○ UTGST (OT)	Rs. 10.94 Crores
○ IGST:	Rs. 1,46,730.03 Crores
○ Comp. Cess:	Rs. 2,359.44 Crores

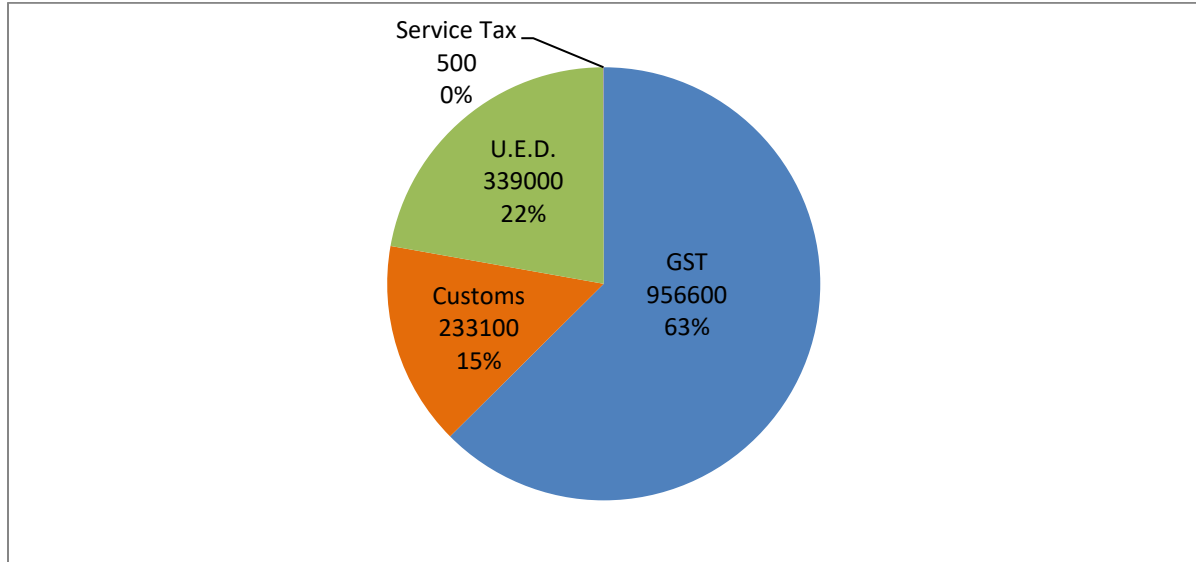

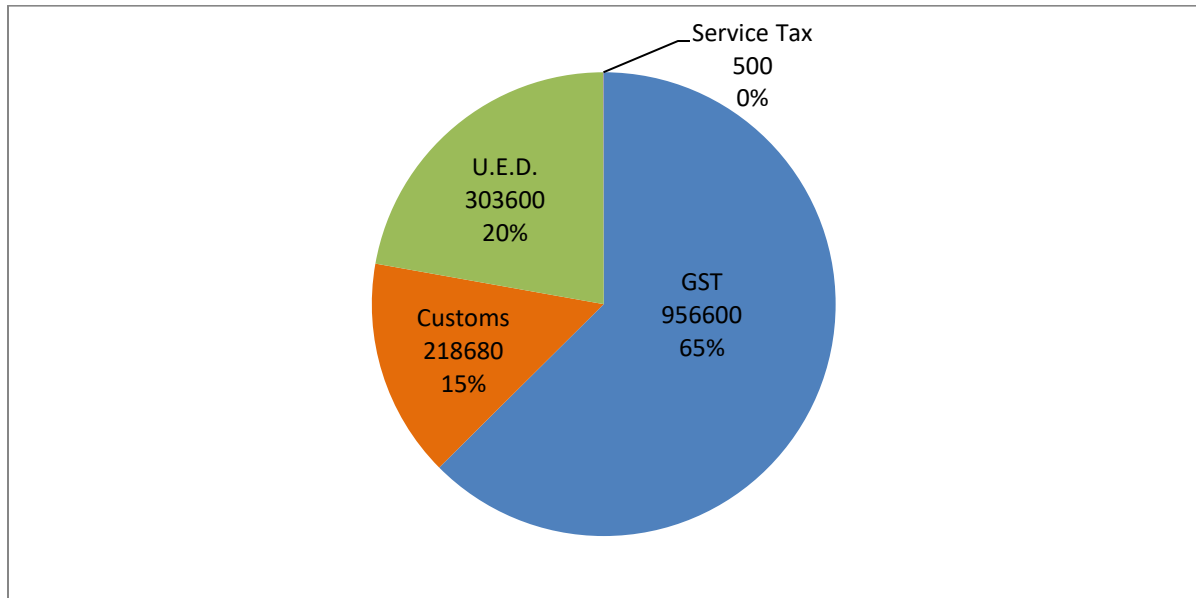
Total Budget Estimate Rs. 15,29,200 Crores

Total Revised Estimate Rs. 14,79,380 Crores



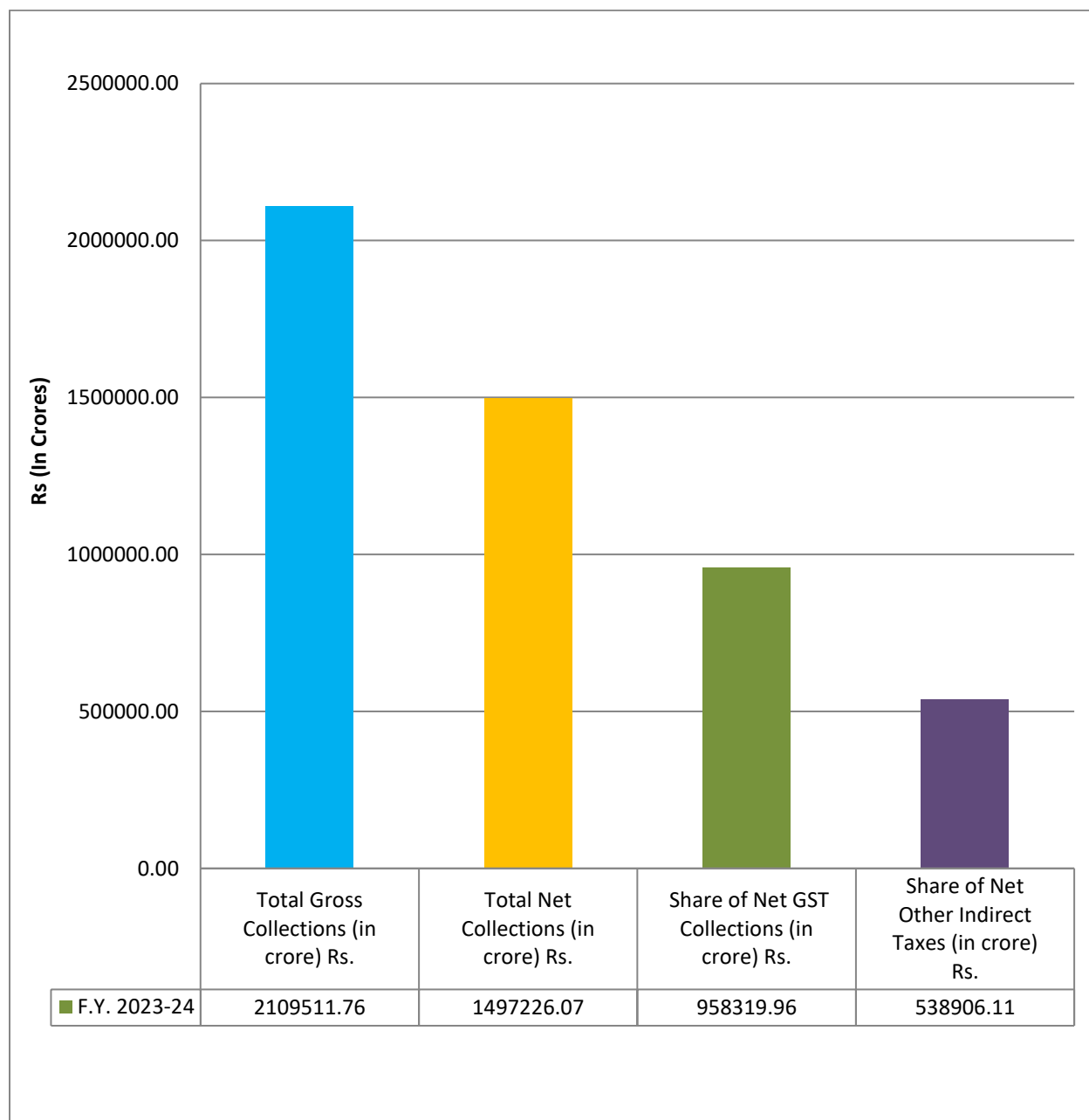

Cumulative Collections Upto March (Final), 2024

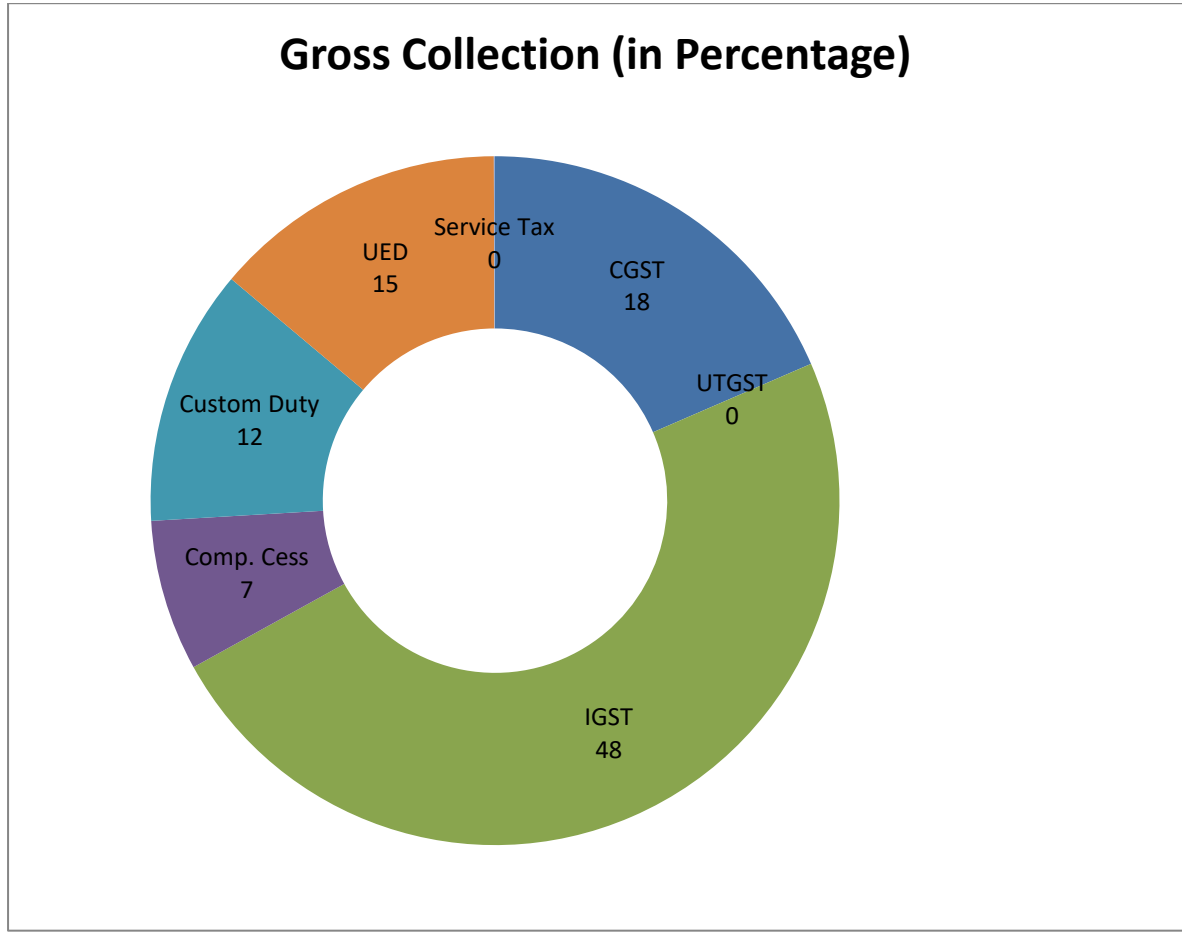

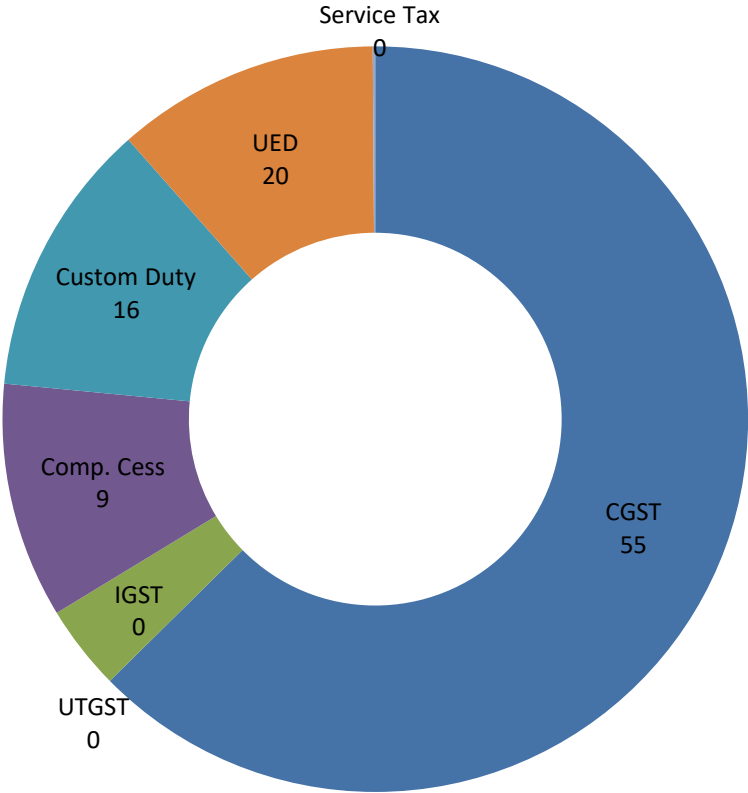

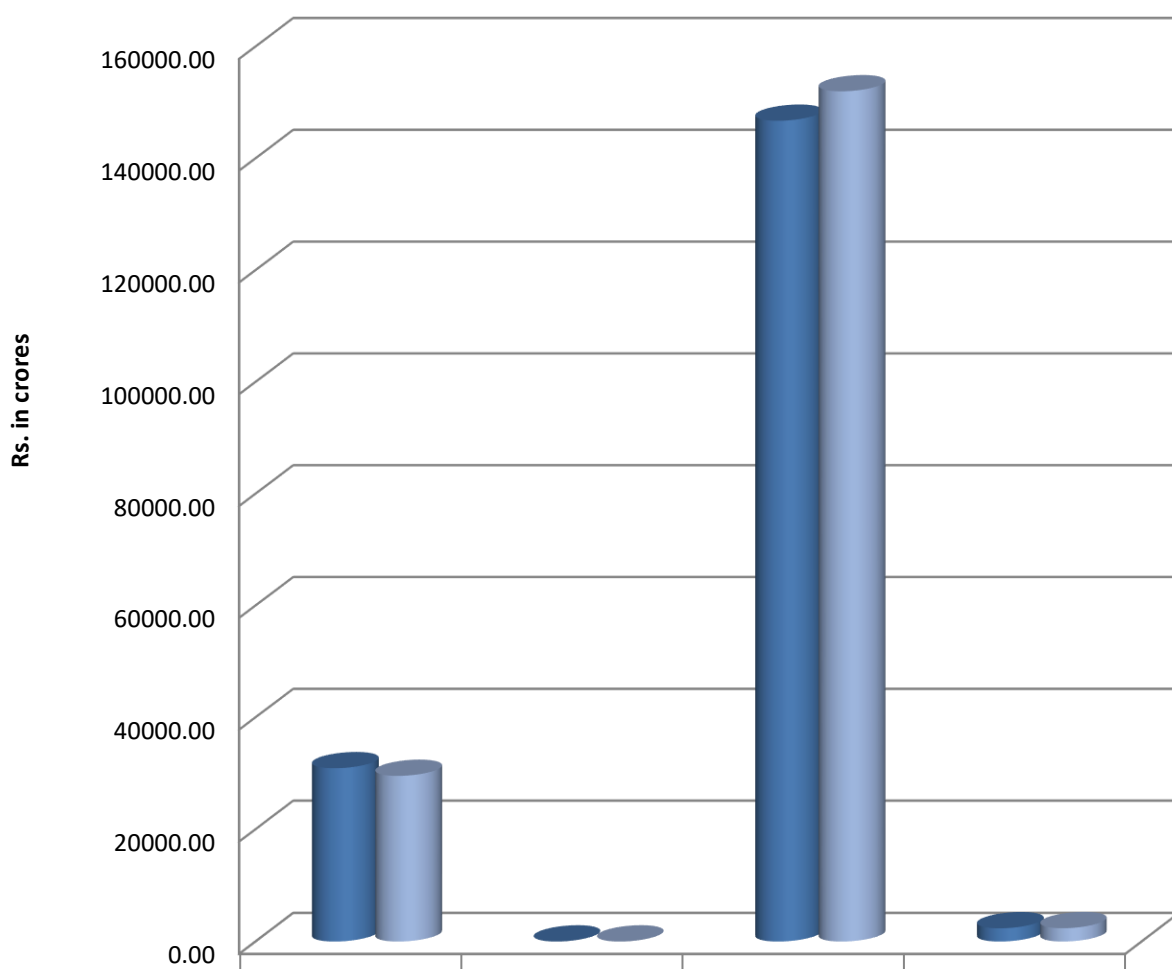

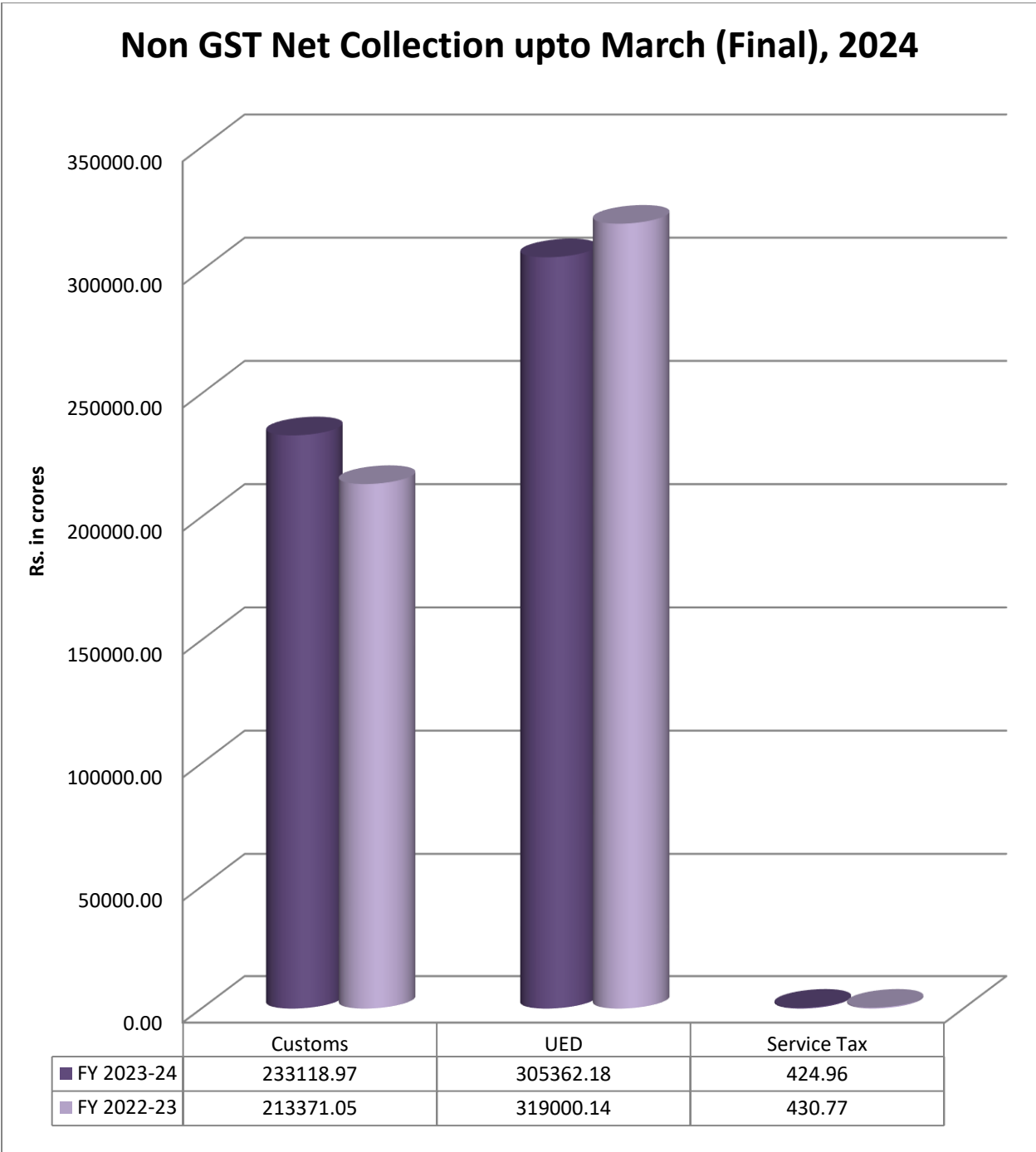
GST Net Collections upto March (Final), 2024



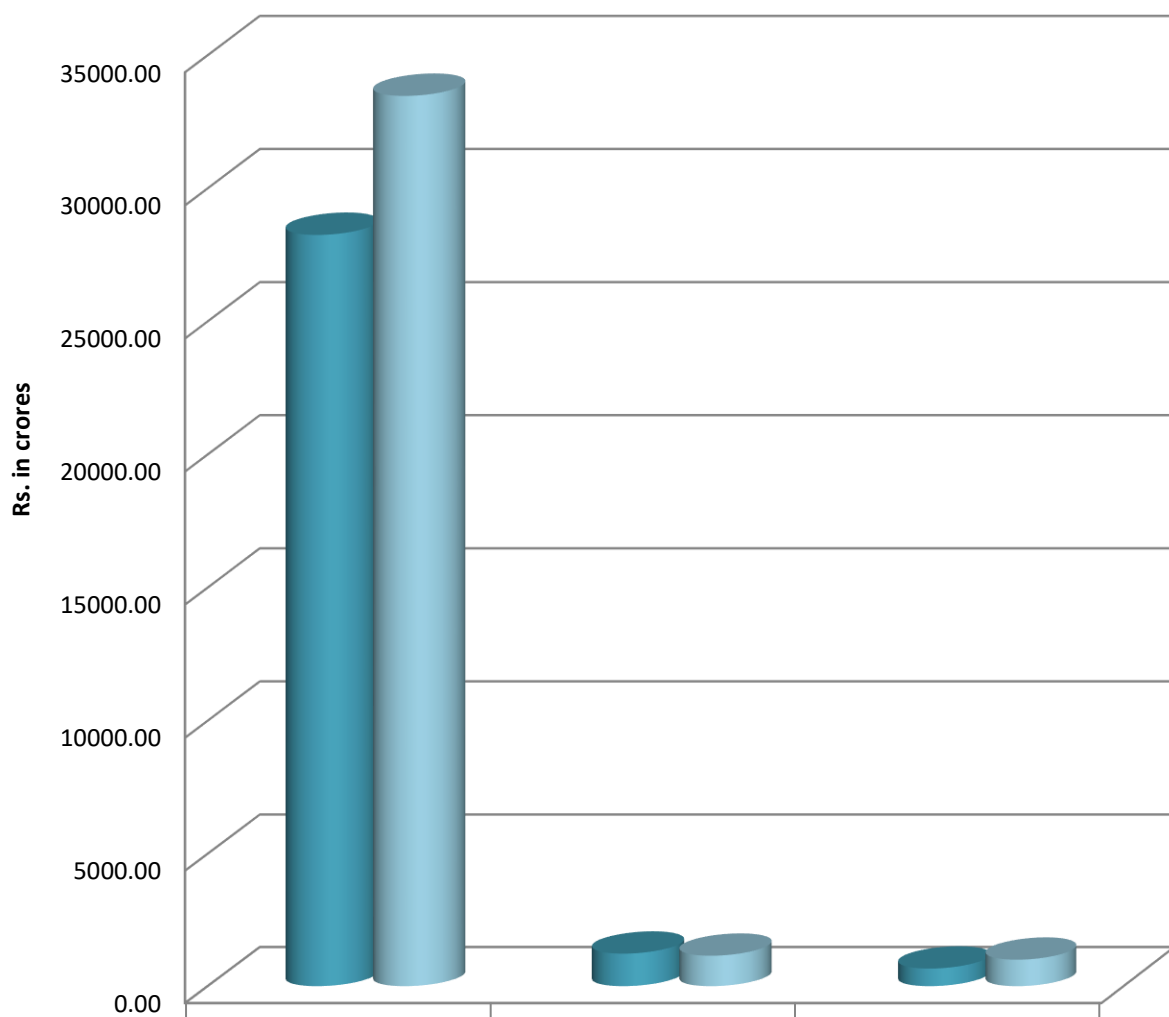
GST Refund upto March (Final), 2024

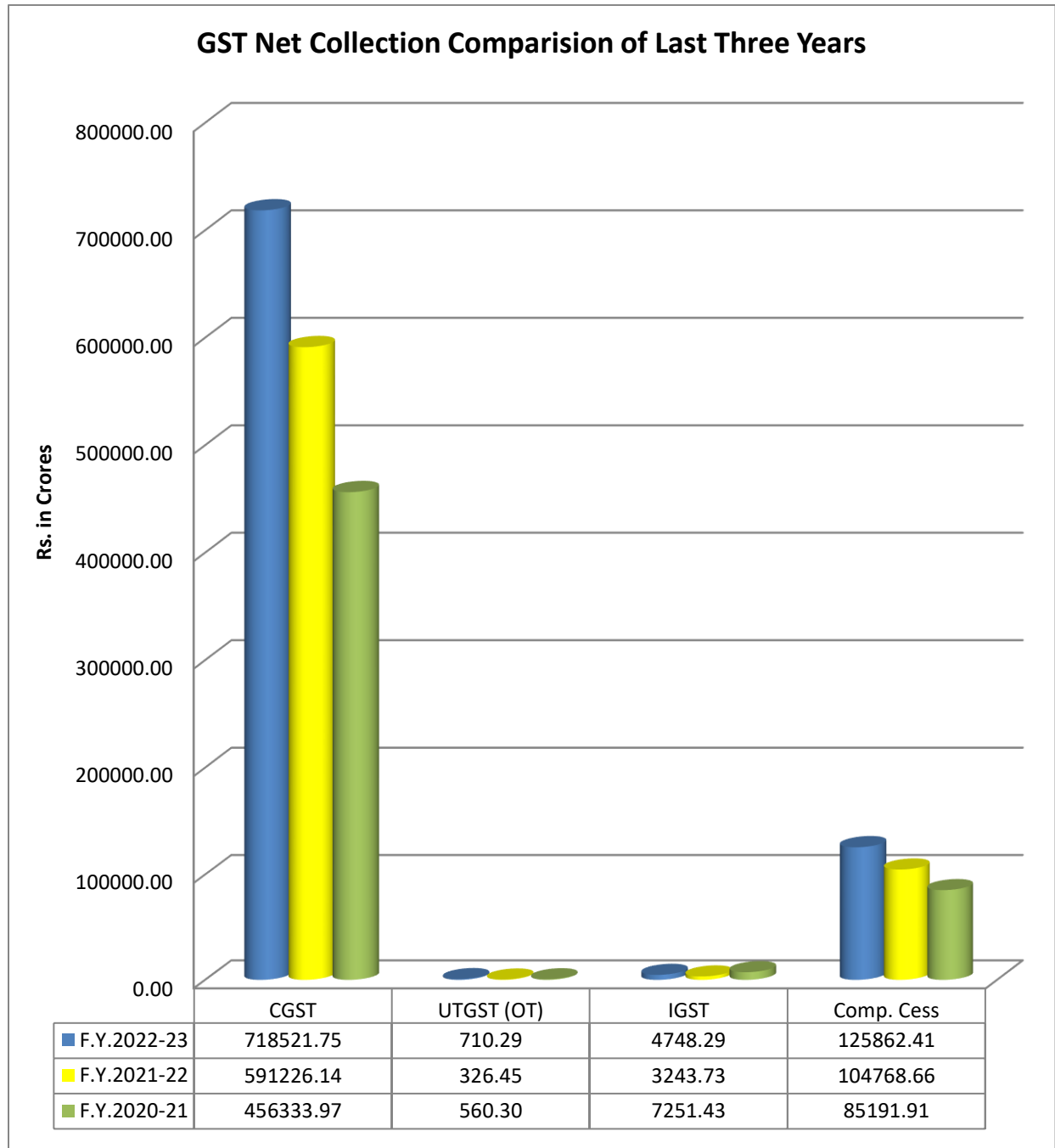


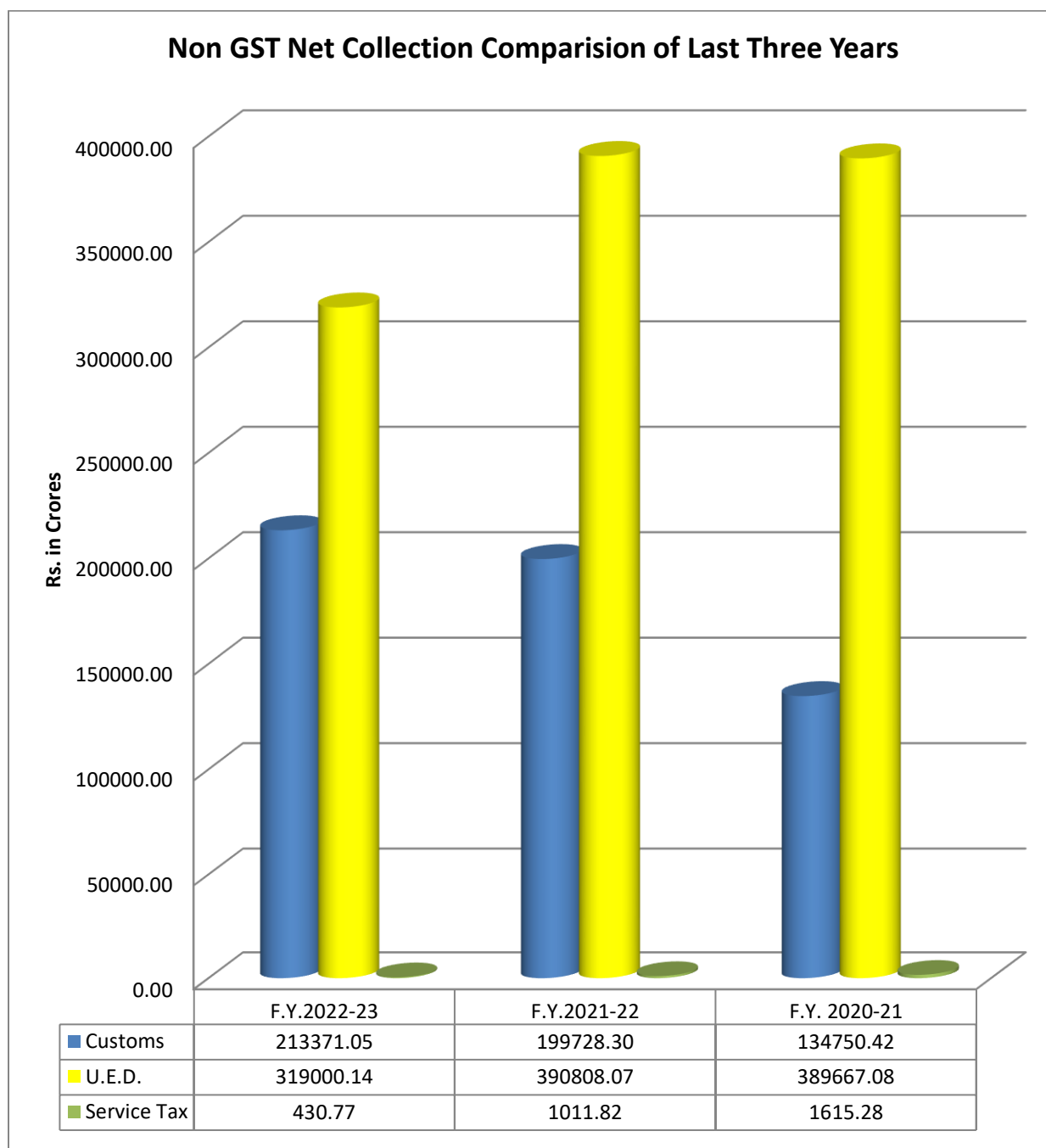

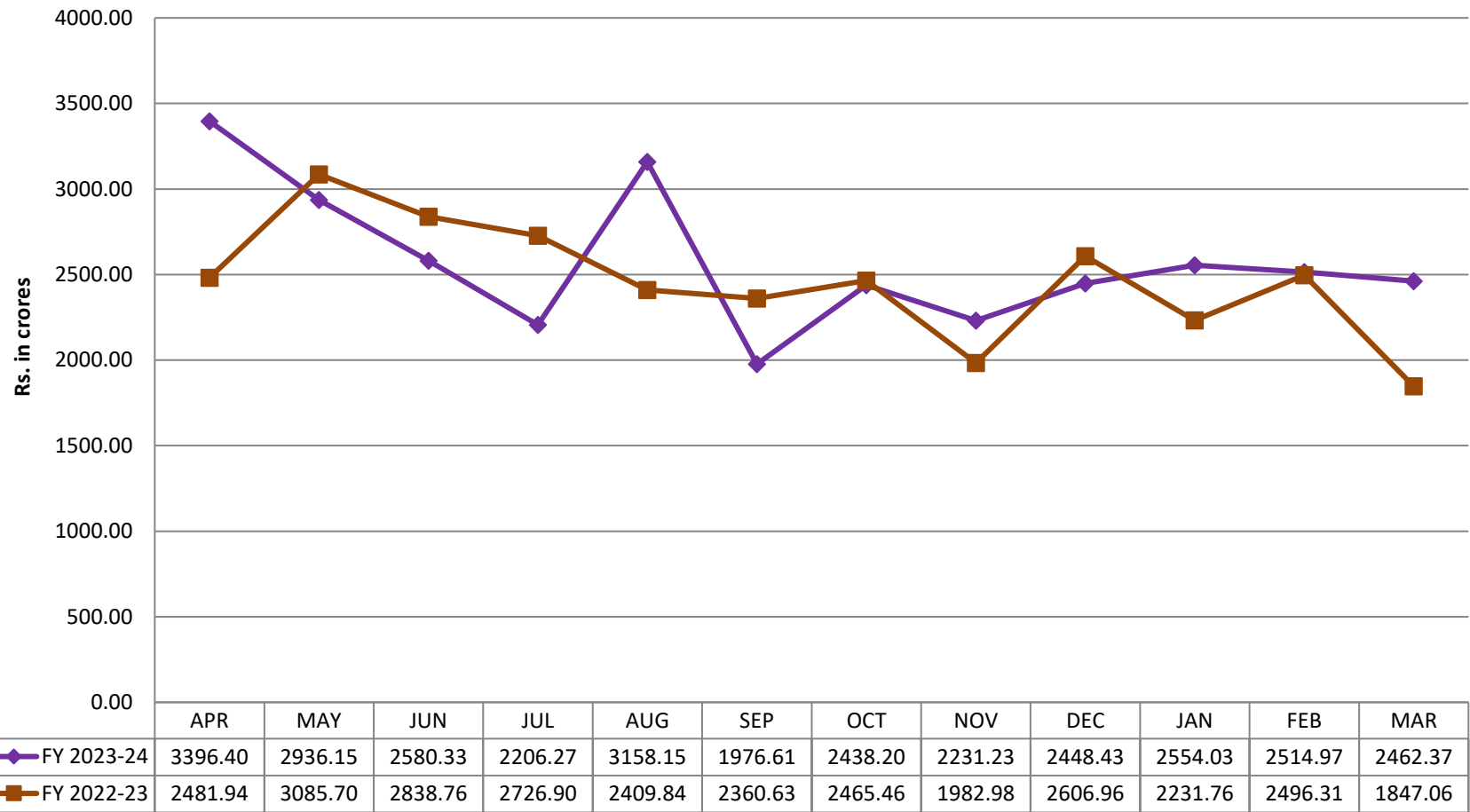

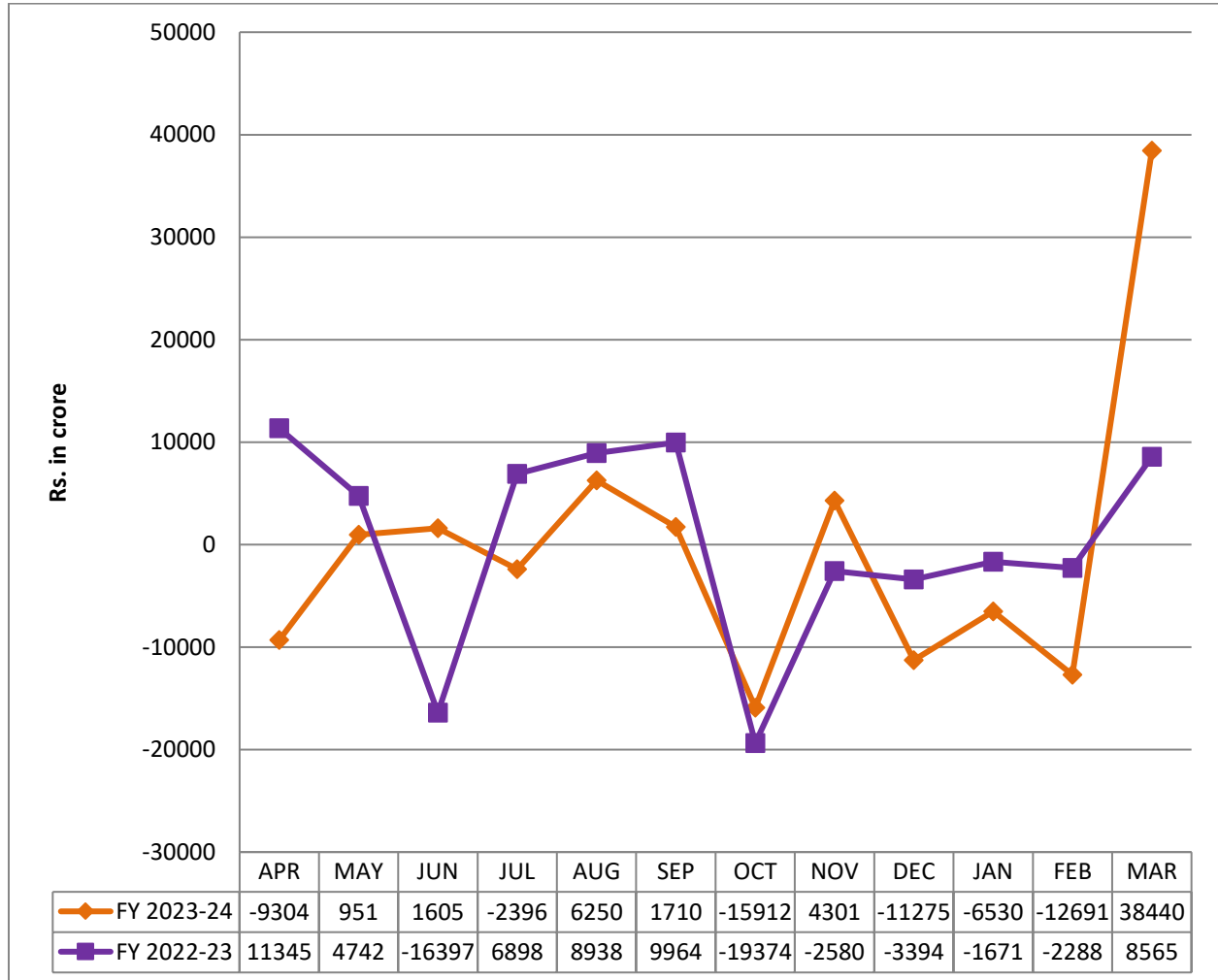

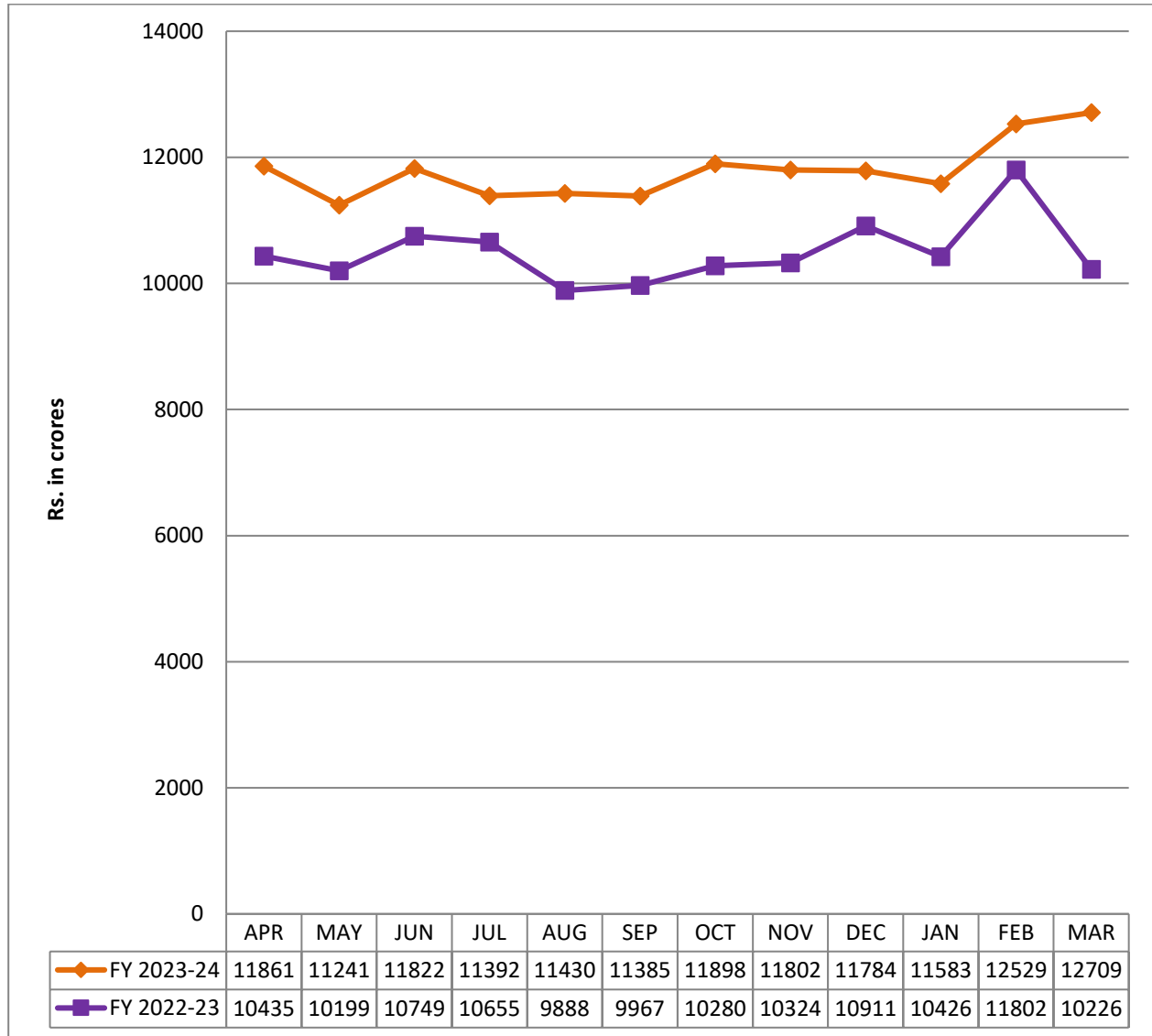

Compensation Cess (Refund) Monthly Trends

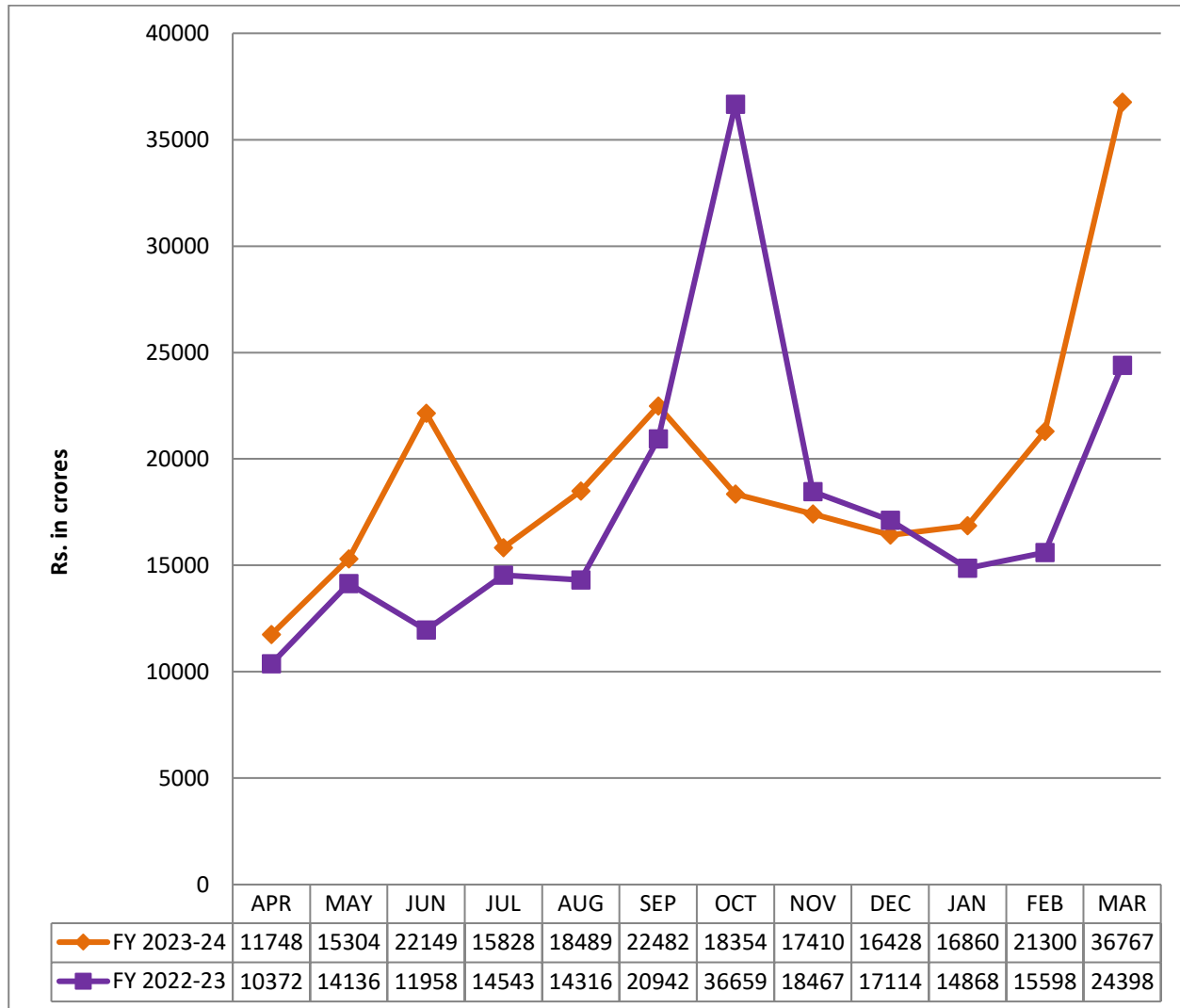

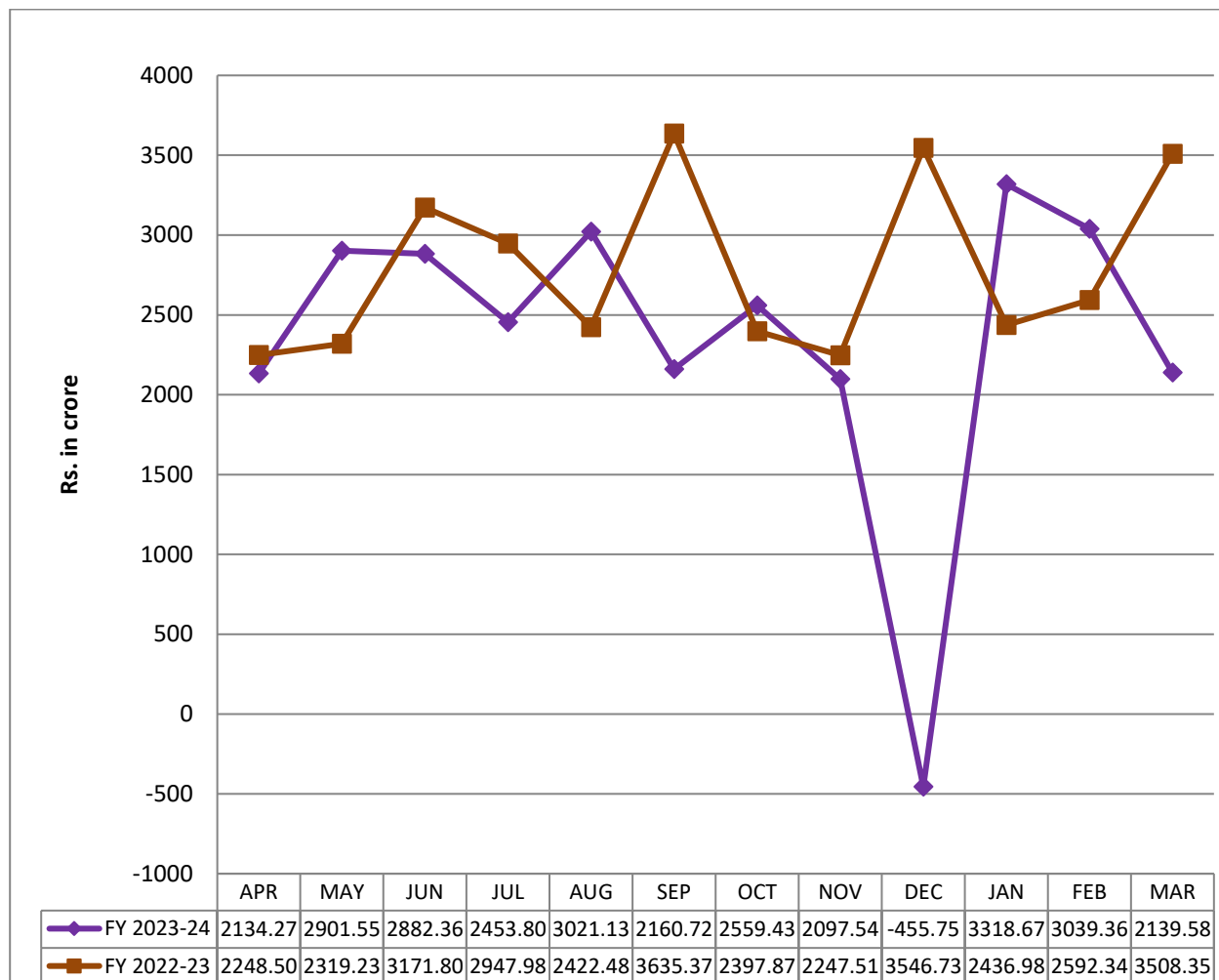

Custom Duty (Refund) Monthly Trends

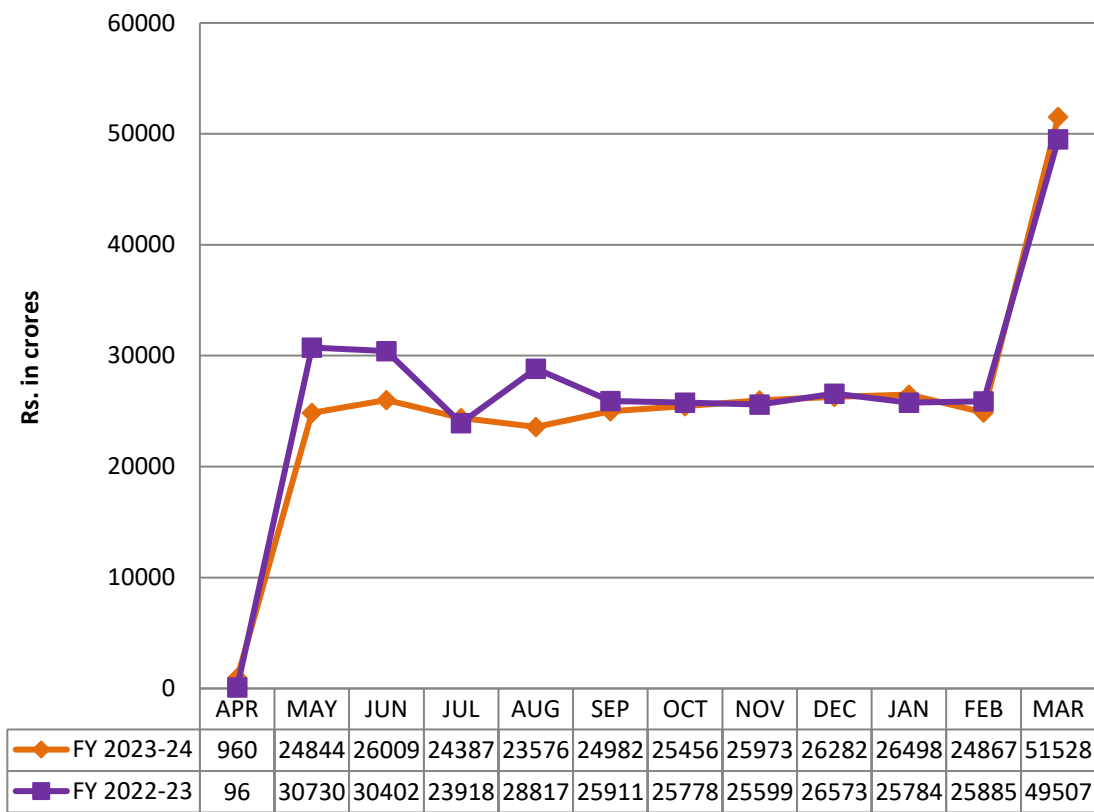

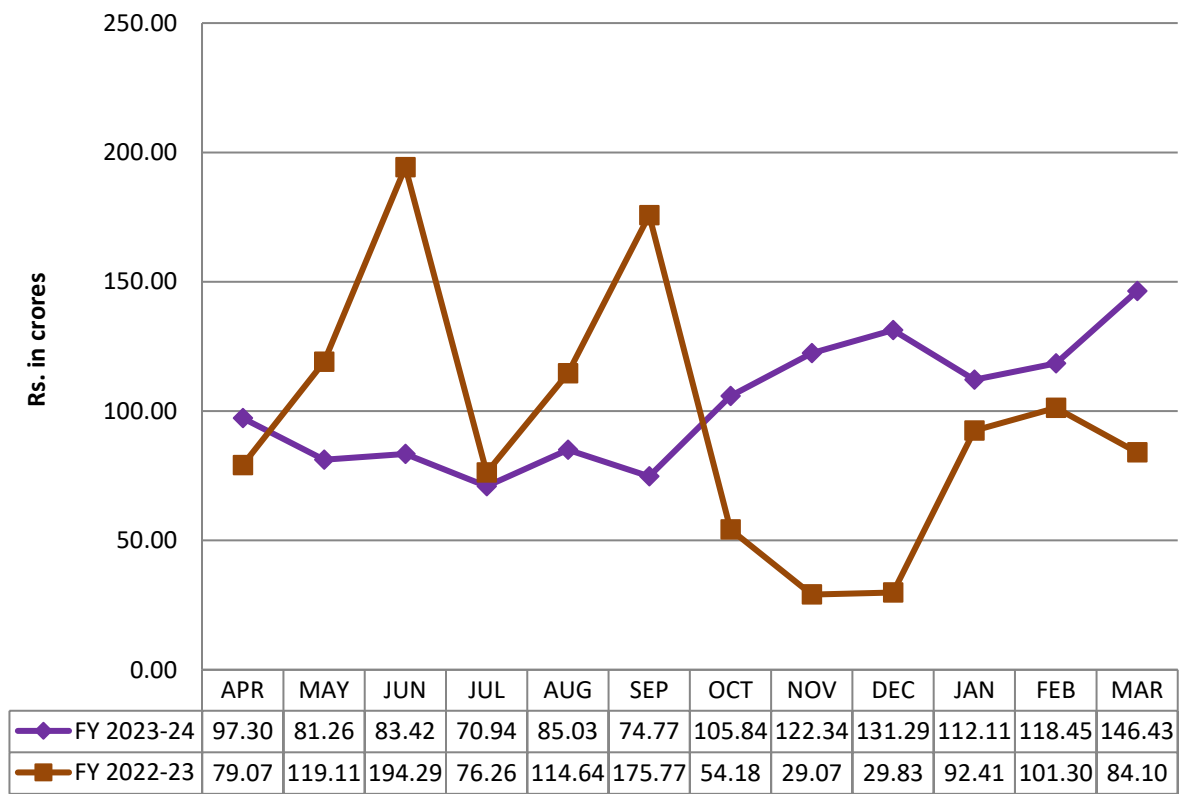

Monthly Trends Union Excise Duty (Refund)

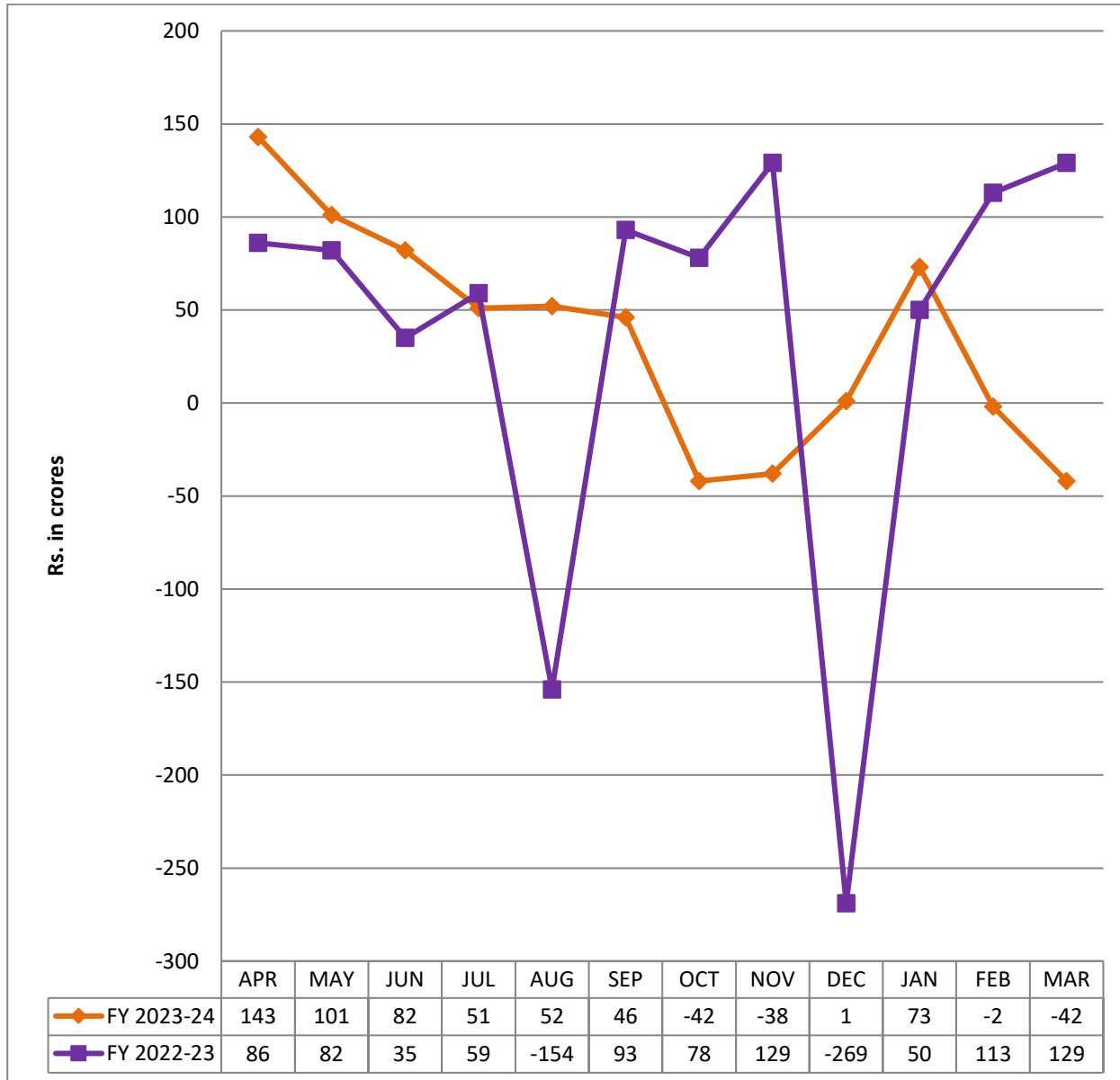

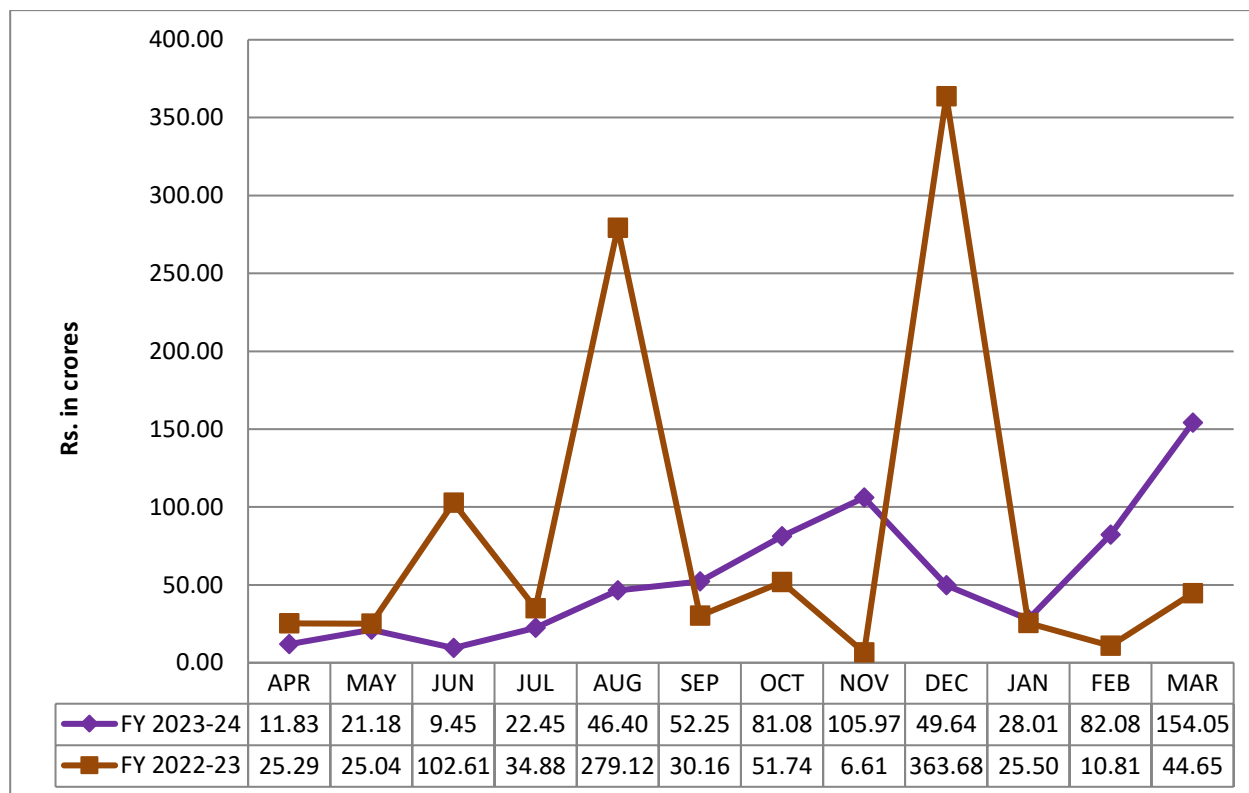
