Dear Madam,

The Central Pension Accounting Office (CPAO) has constantly endeavoured to improve the Ease of Living of the Pensioners by introducing new initiatives like the introduction of e-Pension Payment Order (e-PPO), e-Special Seal Authority (e-SSA), Web Responsive Pensioners' Service (WRPS), etc. However, until now the initiatives of CPAO have been for pensioners who have already retired from Government service.

It has been seen that many employees of the Government of India who are on the verge of retirement need guidance regarding issues related to management of post-retirement finances, how to best to look after their mental and physical health, etc. CPAO is, therefore, trying to develop a program for guidance of retiring Central Civil Pensioners. However, to carry out a projection of the demand for the program data regarding the month wise number of pensioners, who will be retiring till the end of March, 2023 is required.

I would, therefore, request that the Pay & Accounts Officers working under your jurisdiction may be asked to forward the required data in the attached format by 31st May, 2022.
