
Reference is invited to your office email dated 07.06.2021 on the subject cited above.

The O/o CGA, New Delhi vide letter No.R-23001/1/2021-GBA-CGA/545 dated 25.06.2021 has conveyed the approval of Competent Authority for authorization of HDFC **Bank** for collection of Customs Duty through electronics mode (for challans generated through ICEGATE/EDI system). The bank also have to complete all integration with ICEGATE, e-PAO Customs and RBI for sharing scrolls, challans, DMS, Settlement etc. as per standing instructions in this regard.

3. Further, it is also intimated that for the authorization of physical collection of Customs Duty, separate and complete proposal from Bank along with feasibility and requirement of specific Commissioner for Customs location authorization may please be provided to proceed further in the matter.

This issues with the approval of Competent Authority.




